With the hard work and advocacy of the board, residents, and our elected officials, we have been able to do great things for Lamond-Riggs this program year. Our elected officials have advanced full funding for reconstruction of the Lamond-Riggs Library, funding for inclusion of the Riggs Road/South Dakota Avenue NE corridor in the Main Street program to provide support for and grow small businesses along the corridor, and funding for a clean team for the corridor. We are happy to report that the DPR playground at the Riggs-LaSalle Recreation Center will be opening to the community outside of school hours by October 1, 2018, and hopefully as early as July.

#### Metro Red Line Service Work July 21 – September 3

- Rhode Island Avenue & Brookland stations closed.
- No Red Line service between Fort Totten and NoMa-Gallaudet stations; use Green Line as alternate.
- Shuttle buses provide service between Fort Totten, Brookland, Rhode Island Ave, and NoMa-Gallaudet stations. Red Line trains will operate in two segments: between Shady Grove & NoMa-Gallaudet and between Fort Totten & Glenmont.
- Rush Hour Promise will remain in effect for most rail customers; however, certain Red Line trips will be excluded due to service adjustments.

#### DC Fire & EMS Cadet Program

Minimum Requirements

- Be a DC Resident
- Be a DC Public, Public Charter or Parochial High School Graduate, with a diploma or GED
- Be between the ages of 18 21 years old at the time of application
- Have had a cumulative high school GPA of 2.5
- Have a driver's license, provisional license or learner permit at the time of application

Once evaluated and selected Cadets earn an annual salary of \$22,526 and accrue 4 hours of paid annual and sick leave bi-weekly. Upon successful completion of the Program, new Firefighter EMT recruits will earn a starting salary of \$48,881 annually, accrue 4.5 hours of paid annual and sick leave bi-weekly, and have access to health and life insurances and union representation.

LRCA General Membership Meeting Minutes LaSalle-Backus Education Campus May 7, 2018

President Uchenna Evans opened the meeting with a silent invocation at 7:06 PM. Riggs Park Day is set for May 19 at the Riggs LaSalle Recreation Center at 12 p.m. Volunteers are needed for set-up, day-of tasks, and clean up. Survey for Art Place programming and retail will be shared online on the LRCA website. A farm stand is coming to UDC Backus in early June - focus groups will be held and a survey conducted. Minutes from the April meeting approved by membership.

Current LRCA bank balance reported Financial Secretary at \$5,555.01. Financial report approved by membership.

MPD 4D Commander Randy Griffin, Cpt. Pamela Wheeler-Taylor, Cpt. Bryan Christian, Lt. Ozetta Posey – Theft from auto is increasing. Lt. Posey encourages everyone to remove all valuables from cars. More patrols will be added to combat speeding traffic and gun crimes. Lt. Posey urges the community to call 911 whenever there is suspicion of criminal activity – always call MPD first. If MPD's response time is too long or MPD is nonresponsive, you can contact Lt. Posey directly to let her know, but everyone should always call 911 first. Barbara Mitchell, Legislative Director to Ward 5 Councilmember Kenyan McDuffie – Budget items secured are: street, alley, and curb projects in areas with significant senior populations; funding of Main Street initiatives including a Clean Team; Lamond-Riggs Library construction funds – LRCA President Uchenna Evans, Lamond-Riggs Library Friends President Robert Oliver, and ANC Commissioner Frank Wilds (5A01) to serve on the DCPL Design Team Panel; Remodel Cities; and sponsorship of the Charles Hamilton Houston statue. Lack of maternity wards in eastern city neighborhoods continue to be an issue of concern.

<u>LaRoya Huff, Community Liaison to Ward 4 Councilmember Brandon Todd</u> – DPW can replaced at 6<sup>th</sup> and Madison NE. DDOT repaving of Riggs Road and Eastern Avenue NE addressed. There will be a meet and greet at Culture Coffee Too in June. CM Todd will host a Living Room chat – date to be determined. There is a security camera incentive program for DC residents who want to install cameras on their property - <a href="https://ovsjg.dc.gov/service/private-security-camera-system-incentive-program">https://ovsjg.dc.gov/service/private-security-camera-system-incentive-program</a>

Phillip McAuley, Ward 4 MOCR – Recommends community to apply for the security camera rebate program, especially considering the crimes at the 700-800 blocks of Oglethorpe Street NE. Over 10,000 have taken advantage of the program so far. Ward 4 businesses have received over \$2.6 million in funding through the Great Streets Program. The DC Funk Festival Parade is scheduled for May 12 at 4 p.m. Meet at Howard Theater, 620 T Street NW at 3 p.m. if interested. <u>Jim Sebastian, DDOT Associate Director for the Planning and Sustainability Division</u> – Discussed the extension of the Metropolitan Branch Trail (MBT) from Brookland to the Fort Totten Metro Station. The goal of the MBT is to link Silver Spring, MD to Union Station in Washington, DC via bicycle trails. The extension runs from John McCormack Drive to the Fort Totten Metro Station and will include a new sidewalk on the south side of Galloway Street NE opposite The Modern apartment community. Expected start date is June 2018 with completion estimated for November 2019. Visit <a href="https://www.metbranchtrail.com">www.metbranchtrail.com</a> for more information.

Evan Goldman, VP of Land Acquisition and Development for EYA – There will be 163 houses in the new Fort Totten South development coming to South Dakota Avenue and Riggs Road NE, all three-bedroom homes except for approximately 15 two-bedroom townhomes. There will be 29 homes reserved for below market rate sale (half will be at 50% AMI, the other half at 80% AMI). Development will have 20,000-25,000 sq. ft. of retail along Riggs Road. LRCA negotiated community benefits package with value of \$325,000, \$200,000 of which will go to public space improvements. BZA hearing will be on May 30, 2018. Average market price for the homes estimated to be \$500k-\$600k. Info available on LRCA's website at http://lrcadc.org/development.

<u>DC Candidate Meet & Greet</u> – Primary election on June 19, 2018. All candidates for DC Council At-Large & DC Council Chair were invited to participate in a meet and greet. Marcus Goodwin (At-Large candidate), Jeremiah Lowery (At-Large candidate), and Ed Lazere (DC Council Chair candidate) attended. The LRCA does not make political endorsements.

<u>Lisa Wray, 70<sup>th</sup> Anniversary Committee</u> – The planning committee met in May to discuss the Fall lunch celebration for LRCA's 70<sup>th</sup> anniversary. Additional details will be shared at the June LRCA meeting.

<u>LaSalle-Backus Principal Justin Ralston</u> – The library was renovated a couple weeks ago – over \$30,000 renovation. The school is hosting their second annual career day on June 1. Anyone interested in presenting on what they do and inspire kids is welcome to participate.

#### How to Dispose of Something in DC

Disposing of trash and recyclables the right way helps keep our city clean, beautiful, and healthy. To take the guesswork out of waste disposal and recycling, Department of Public Works (DPW) created a new web app (available at: <a href="https://zerowaste.dc.gov/">https://zerowaste.dc.gov/</a>) that allows residents to type in almost any item they can think of, after which they will be provided with information on how that item should be properly disposed of, recycled, reused or composted in the District. If DPW collects your trash and recycling, you've also likely received a postcard from them with reminders on how to prepare your trash and recyclables for collection. Some of the reminders include not putting recyclables in plastic bags, and when bins should be set out and removed from the curb.

Note: Trash that is left outside of garbage cans will not be picked up. You must request a bulk pick-up if you plan to have trash that exceeds your cans. DPW can be reached via phone at (202) 673-6833.

#### Lamond-Riggs Library Update from DC Public Library

The Lamond-Riggs Library, at 5401 South Dakota Ave. NE, is going to be rebuilt. The project is fully funded at \$20 million.

In March 2018, the DC Public Library (DCPL) issued a Request for Qualifications (RFQ) to select a design build team. Nine firms responded, and the Library has chosen three finalist teams to present proposals through a Request for Proposals (RFP) process to DCPL's architect selection panel. Three community members, chosen by Council Member Kenyan McDuffie, will serve on the selection panel to choose the design-build team for the new Lamond-Riggs Library.

The design process will begin in Summer 2018 and will take approximately 16 months. Once the design is complete, the current building will be closed and DCPL will provide library services at an interim location during construction. The new building will open in Fall 2021.

Community engagement is a vital aspect of the library design process. DCPL gathers input in a variety of formats, including surveys, focus groups and community meetings. To date, DCPL has conducted an initial survey (electronic and paper) that received more than 100 responses, and DCPL has begun targeted focus groups with customers to get a sense of what they would like to see in their new library. In addition, DCPL gathers demographic data and growth projections to inform the design. DCPL will provide regular updates on the website, dclibrary.org/newlamondriggs.


#### Bertie Backus Farm Stand Opening June 9, 2018
