

HADOOPREVEALED INC. DBA BIGDATAREVEALED SERVER END USER LICENSE AGREEMENT

READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE OPENING THE PACKAGE CONTAINING THE PROGRAM DISKETTES, THE COMPUTER SOFTWARE THEREIN, AND THE ACCOMPANYING USER DOCUMENTATION (COLLECTIVELY, THE "PROGRAM"). THE PROGRAM IS COPYRIGHTED AND LICENSED (NOT SOLD). THE TERMS OF THIS LICENSE AGREEMENT ALSO APPLY TO ANY UPDATES OR SUPPLEMENTS TO THE ENCLOSED SOFTWARE AND DOCUMENTATION. BY OPENING THE PACKAGE CONTAINING THE PROGRAM OR BY INSTALLING, COPYING, DOWNLOADING, ACCESSING OR OTHERWISE USING THE SOFTWARE, YOU ARE ACCEPTING AND AGREEING TO THE TERMS OF THIS LICENSE AGREEMENT. IF YOU ARE NOT WILLING TO BE BOUND BY THE TERMS OF THIS LICENSE AGREEMENT, YOU SHOULD PROMPTLY RETURN THE PACKAGE IN UNOPENED FORM OR YOU SHOULD NOT INSTALL OR USE THE SOFTWARE, AND SHOULD RETURN THE PROGRAM TO YOUR PLACE OF PURCHASE, AND YOU WILL RECEIVE A FULL REFUND OF YOUR MONEY. THIS LICENSE AGREEMENT REPRESENTS THE ENTIRE AGREEMENT CONCERNING THE PROGRAM BETWEEN YOU AND Hadooprevealed INC. DBA BigDataRevealed, AN ILLINOIS CORPORATION (REFERRED TO AS "LICENSOR"), AND IT SUPERSEDES ANY PRIOR PROPOSAL, REPRESENTATION, OR UNDERSTANDING BETWEEN THE PARTIES.

1. General Grant of License. Licensor hereby grants to you, and you accept, a nonexclusive license to use the Program Diskettes, download link or other installation formats and the computer programs contained therein in machine-readable, object code form only (collectively referred to as the "Software"), and the accompanying User Documentation, only as authorized in this License Agreement. You may install and register one version of the Software to a designated computer. All users must direct all data, data files, databases or output to the designated computer. Licensor reserves the right to audit and verify that you are in compliance with this license agreement. You agree that you will not assign, sublicense, transfer, pledge, lease, rent, or share your rights under this License Agreement. You agree that you may not reverse assemble, reverse compile, or otherwise translate the Software. All rights not expressly granted are reserved by Licensor.

Upon loading the Software into the designated computer and or Cloud environment/platform, you may retain the Program Diskettes or install format(s) for backup purposes. In addition, you may make one copy of the Software on a second set of diskettes (or on cassette tape) for the purpose of backup in the event the Program Diskettes are damaged or destroyed. You may make one copy of the Documentation for backup purposes. Any such copies of the Software or the Documentation shall include Licensor's copyright and other proprietary notices. Except as authorized under this paragraph, no copies of the Program or any portions thereof may be made by you or any person under your authority or control.

2. Licensor's Rights. You acknowledge and agree that the Software and the Documentation are proprietary products of Licensor and may be protected by applicable copyright and intellectual property laws. You further acknowledge and agree that all right, title and interest in and to the Program, including associated intellectual property rights, are and shall remain with Licensor. This License Agreement does not convey to you an interest in or to the Program, but only a limited right of use revocable in accordance with the terms of this License Agreement.

3. License Fees. The license fees paid by you are paid in consideration of the licenses granted under this License Agreement.

4. Term. This License Agreement is effective upon your opening of this package and shall continue until terminated. You may terminate this License Agreement at any time by returning the Program and all copies thereof and extracts there from to Licensor. Licensor may terminate this License Agreement upon the breach by you of any term hereof. Upon such termination by Licensor, you agree to return to Licensor the Program and all copies and portions thereof.

5. Limited Warranty. Licensor warrants, for your benefit alone, for a period of 90 days from the date of receipt of the Program (referred to as the "Warranty Period") that the Program Diskettes in which the Software is contained are free from defects in material and workmanship. Licensor further warrants, for your benefit alone, that during the Warranty Period, the Software shall operate substantially in accordance with the functional specifications in the Documentation. If, during the Warranty Period, a defect in the Program Diskettes or Software appears which violates this Limited Warranty, you may return the Program Diskettes or Software, respectively, to Licensor (along with a copy of your receipt) for either repair or replacement or, if so elected by Licensor, Licensor may refund the license fees paid by you under this License Agreement. You agree that the foregoing constitutes your sole and exclusive remedy for breach by Licensor of any warranties made under this Agreement. Any repair or replacement by Licensor hereunder will be warranted for the remainder of the original Warranty Period or thirty (30) days, whichever is longer. This Limited Warranty is void if any defect in the Program Diskettes or Software has resulted from accident, abuse or misapplication. **EXCEPT FOR THE WARRANTIES SET FORTH ABOVE, THE PROGRAM, INCLUDING THE SOFTWARE, IS LICENSED "AS IS," AND LICENSOR AND ITS SUPPLIERS DISCLAIM ANY AND ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT.**

6. Limitation of Liability. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL LICENSOR OR ITS SUPPLIERS BE LIABLE FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, OR EXEMPLARY DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION OR ANY OTHER PECUNIARY LOSS) ARISING OUT OF THE USE OF OR INABILITY TO USE THE PROGRAM, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN ANY CASE, LICENSOR'S CUMULATIVE LIABILITY TO YOU OR ANY OTHER PARTY FOR ANY LOSS OR DAMAGES RESULTING FROM ANY CLAIMS, DEMANDS, OR ACTIONS ARISING OUT OF OR

RELATING TO THIS LICENSE AGREEMENT SHALL NOT EXCEED THE LICENSE FEES PAID TO LICENSOR FOR THE USE OF THE PROGRAM. SOME STATES DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

7. Trademark. No right, license, or interest to any trademarks or service marks of Licensor is granted hereunder.

8. Governing Law and Venue. This License Agreement shall be construed and governed in accordance with the internal laws of the State of Illinois (without giving effect to its conflict of law rules). Any disputes arising under or related to this license agreement shall be brought solely in the state or Federal courts located in Lake County Illinois.

9. Costs of Litigation. If any action is brought by either party to this License Agreement against the other party regarding the subject matter hereof, the prevailing party shall be entitled to recover, in addition to any other relief granted, reasonable attorney fees and expenses of litigation.

10. Severability. Should any term of this License Agreement be declared void or unenforceable by any court of competent jurisdiction, such declaration shall have no effect on the remaining terms hereof.

11. No Waiver. The failure of either party to enforce any rights granted hereunder or to take action against the other party in the event of any breach hereunder shall not be deemed a waiver by that party as to subsequent enforcement of rights or subsequent actions in the event of future breaches.
