Minutes of the Parish Council Meeting held at Littlethorpe Village Hall

at 19:30 on Monday 15 January 2018

Present: Cllr Spoors (Chair), Cllr Winterburn, Cllr Gray, Cllr Laugher, Cllr Orme, District Cllr Galloway, and **three** members of the public.

- 1 Apologies Apologies were received from County Cllr Harrison
- 2 Declarations of interest None declared further to those on the Borough Council Website
- 3 Chairman's remarks Both items, the Bellwood Development and restoration of the railway line appear later on the agenda
- 4 Adoption of the minutes of the Parish Council meeting on 13 Nov 17 was proposed by Cllr Winterburn, seconded by Cllr Gray and passed unanimously.
- 5 There was no County Councillor's report
- 6 District Cllr Report
 - .1 The Draft Local Plan will be out for final consultation from 26 Jan 9 Mar 18. Thereafter it will be forwarded to the Secretary of State for approval early 2019. Comments will be restricted to the soundness of the proposals.
 - .2 The General Data Protection regulations come into force on 25 May 18. Cllr Orme questioned whether they would apply to a Parish Council as small as Littlethorpe. Cllr Galloway offered to investigate.
 - .3 Harrogate Borough Council tax will increase by 2.2% average: £5 for band D and below, more for A-C
 - .4 The Village Hall has not used all 5 Commuted Sums to which it has been eligible since 2010
- 7 RFO's report
 - .1 Payments made: £72 for hire of village hall, £39.17 for printer ink
 - .2 Salary and tax for Clerk await instruction for mechanism to do so Action: the Clerk
 - .3 Transfer of the account to HSBC will begin on receipt of the forms from HSBC

- 8 Correspondence
 - .1 Gaming Solutions Ltd wrote to confirm that they had asked all employees to drive with due consideration to the residents on Littlethorpe Lane
 - .2 Bellwood Development. The correspondence between Brig Wardle and Cllr Spoors was summarised.
 - a The Parish Council has objected to the Bellwood development on the grounds that access to the A61 Harrogate Road is not suitable, the substantial development is within the Parish, but not part of the existing settlement, and that the area of special scientific interest at Quarry Moor would be enclosed by buildings on three sides.
 - b This is the fourth application for the site since 1995, the last in 2015, turned down by Harrogate Borough Council. The current application has only one access that is onto the A61 close to the roundabout at the West end of Ripon bypass.
 - c Proposal made to write to Highways Dept.: they have acknowledged receipt of the planning application on 22 Dec 17 and will respond after consideration.

- .3 17/05400/REM: Reserved matters application for erection of 1 no. dwelling with Layout, Appearance and Landscaping considered under Planning Permission 17/03478/OUT -Outline planning application for the erection of one detached dwelling with access and scale considered. - 10 Public Time
 - .1 Knaresborough Road is unsafe because of the narrowness of the road and the roadside hedges that have not been cut. Proposal made to write to North Yorkshire County Council and contact landowners with unkempt hedges. Action: the Clerk
 - .2 A proposal has been made to demolish a bungalow on Littlethorpe Road and use it as access to build 35 new houses between Littlethorpe Road and the canal. This land is outwith the Littlethorpe Parish boundary and is liable to flooding.
 - .3 Ripon quarry works are well advanced. A sluice has still to be installed to control the level of water there.
 - .4 A welcome pack for new residents to Littlethorpe is being prepared at St Michael's Church. The authors have asked to include details of the Parish Council within it. Adding the contact details of the Parish Council and a link to the village website was agreed.
 - .5 Littering and overnight parking on the layby of Littlethorpe Lane adjacent to the Ripon bypass was raised at the Nov 17 meeting. The site is within Ripon City Council boundaries. Ripon City Council contacted the roads department and will inspect the site. The roads department replied that there were no parking restrictions within the layby. Littering was reported on the fly tipping notification website and the litter, but not the garden waste, were removed on 12 Jan 18.
- 11 Reinstatement of Harrogate to Ripon railway
 - .1 There has been an exchange of letters in the pages of the Ripon Gazette. Members of the public attending Ripon City Council have been excluded from Council discussions relating to the matter; so there was no new information to report.
