Event Regulations

- This event will be held under the International Sporting Code of the FIA, the National Competition Rules of CAMS, the Speed Event Standing Regulations, The CAMS Come and Try Policy, the Passenger in Vehicle Guidelines, these Supplementary Regulations, and any Further Regulations or bulletins issued by the event organiser. This Event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at www.cams.com.au

This event will be a club non-competitive one car sprint event, including Come and Try activities organized by the Victorian Motorsport and Cruise Club Inc. Held under CAMS permit no. 317/0212/01
- The Organising Committee:** Stuart Thompson (Clerk of Course), Tom Steiniger (Scrutineer), Stuart Hotton, Brett Travers, Tony Hassall, Christoph Mees and Paul Clarke.
- Judges of Fact:** Event – Secretary of the Event, Vehible eligibility – Scrutineers, will be the judges of fact.
- Event Start:** The Event is to start at 8:00 am, Saturday 2 December 2017 at Motorsport Training Facility, Barnawartha, Victoria.
- Event Entry:** Entry forms must be accompanied by the applicable fee of \$120 (\$130 for non members or \$150 if entered on the day of the event). Entries open upon publication of these Regulations and close on the day of the event. The organisers reserve the right to refuse entry in accordance with NCR 83.
- Persons Eligible:** The Event is open to: all financial members of the Victorian Motorsport and Cruise Club Inc. and their guests who hold a L1 or L2S CAMS Licence. Licences can be purchased on the day at a cost of \$25.00 for Level 1 Licences, or \$125 for full Level 2 Speed licences. Level 2 Speed licences may also be purchased prior to the event on the CAMS Website.
- Insurance:** Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.
- Alcohol, Drugs and Other Substances:** Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.
- Compliance with Instruction:** For the duration of the Event, failure to follow the directions of any Official, these Event Regulations, Competitor Bulletins or Further Regulations, as and when published, will render a competitor ineligible to entry onto the track as decided by the Clerk of Course.
- Event Briefing:** The Event Briefing will be conducted at Motorsport Training Facility, Barnawartha, Victoria from 8.45 am on Saturday 2 December 2017. Attendance by all competitors is mandatory and may require 'Sign In'.
- Scrutiny & Documentation:** Scrutiny and documentation will be conducted from 8.00am on Saturday 2 December 2017 at Motorsport Training Facility, Barnawartha, Victoria. All cars must pass Scrutiny

prior to participation in any competition. Required at Scrutiny: Helmets: in compliance with Schedule D of the current CAMS Manual of Motor Sport each occupant, Documentation: CAMS Licence, Club Membership, and if issued, CAMS Vehicle Logbook.

12. **Vehicle Eligibility:** Vehicles may be modified and enhanced for competition. The Organisers reserve the right to reject an entered vehicle modified beyond levels deemed acceptable to the Event. Vehicles shall comply with Schedules A & B of the current CAMS Manual of Motor Sport.

12.1 Vehicles must be in a roadworthy condition for the Event.

12.2 All cars must be fitted with:

Seat Belts to AS E35 or of a type complying with current roadworthy regulations.

If vehicle has a Fire Extinguisher it must be securely fitted (metal bracket preferred) that complies with AS 1841, (except 1841-2), AS 1846 or AS 1848. The capacity of the Extinguisher must be of at least 1 kg capacity, if dry powder.

12.3 Tyres: Only roadworthy tyres will be allowed for the Event, including all Sub-Events. The tyres fitted to the car, as presented at Scrutiny, providing they meet requirements, must be used for the duration of the Event.

12.4 Noise: All competing cars must comply with the maximum exhaust noise level emission of 90dB(A) as appropriate.

12.5 Competition Numbers: The competition number panels are to be affixed to the front passenger window prior to competition.

12.6 All fuel shall comply with Schedule G of the current CAMS Manual of Motor Sport.

13. **Apparel:** Drivers and Passengers must be attired in non-flammable clothing, including cover from ankle to wrist to neck and Helmets. Enclosed shoes must be worn. All apparel shall be in compliance with Schedule D of the current CAMS Manual of Motor Sport.

14. **General Administration:**

- For all Events, all loose objects must be removed from the vehicle.
- Further Regulations and/or Competitor Newsletters will define locations and times not specified in these Regulations.
- There will be no timing or awards as the Event is non-competitive.

15. **Passengers:** Time permitting, there will be the opportunity for experienced drivers to take one passenger for a lap around the track. This must be at reduced speed and under observation of the Clerk of Course.

16. Protests, if any must be lodged in accordance with Part XII of the NCR.

17. Event Organisers reserve the right to cancel, abandon or postpone the event in accordance with NCR 59 of the current CAMS Manual of Motor Sport.

SCRUTINEERING

1. Vehicle to be in a roadworthy condition.
2. Tyres to be roadworthy.
3. Battery to be secured.
4. Wheels to be tight (seriously, people always forget about their wheelnuts!)
5. Seatbelts
6. Seat secured.
7. Helmets to comply with Australian Standards (spare helmets and hairnets available).
8. No loose items in boot, glovebox or console, including spare wheel.
9. No oil leaks or exhaust leaks.
10. No broken lights or lenses.
11. Brake pedal height and operation.
12. Minor safety aspects.
