## Purpose of Post

Assist in the development and deliver a life skills programme for age 16-19 learners, with particular focus on functional skills.

Assist with the recruitment of new learners.

Develop a range of functional skills Maths and English resources to increase understanding of notoriously difficult topics; i.e. fractions, percentages, punctuation.

Assist in carrying out Skills For Life initial assessments, give feedback and produce the necessary learning plans.

Adapt and modify entry level examinations in collaboration with other tutors. To assist in the registering of learners for exams.

Plan and deliver English and Maths functional skills sessions, using a variety of methods to mixed ability groups of learners.

Motivate and support students agreeing clear aims and goals.

Follow set systems and procedures for assessment and verification of qualifications in line with quality systems/procedures.

Liaise with other members of the Basic and Essential Skills Team to ensure cohesive planned approach to delivery of sessions.

Work with students, providing feedback and information on their progress.

Identify and promote opportunities for existing participants to further their Skills For Life development.

Cover foundation learning sessions as requested by Line Manager.
