



Handling Techniques 2 OneMind Dogs 2-day Seminar

April 27-28, 2019

9:00 a.m.-5:00 p.m. with 1 hour lunch break

This seminar is limited to 8 working spots. Each working spot is \$350. Working spots are for both days, no splitting or sharing of sessions will be allowed between handlers. Auditing spots are available for \$75/day.

This 2-day seminar focuses on 8 different OneMind Dogs techniques. Day1 includes the Jaakko Turn, Forced Front cross, Japanese and Running on the Dog's Line. 1 Day 2 includes the Lap Turn, Tandem Turn, Tunnel Brake and Reverse Wrap. Dogs must be proficient on jumps and tunnels, remedial obstacle training will not be part of the curriculum. The focus of this seminar is handling technique training including coursework.

Please note: Our training area is fully fenced, however our neighbors have a variety of farm animals close to the agility field. Sounds and smells of those animals may distract your dog.
