TERMS OF INSTRUCTION

Consent Form

All participants (parent or guardian if under 18 years of age) must sign a consent form and notify their supervisor if any changes have been made since the form was completed.

Risk

There is an element of risk in all outdoor activities and this cannot be completely eliminated. Nonetheless, risks have been assessed and appropriate control measures put in place and will follow National Governing Body recommendations or best practice.

Insurance

Calvin Mason & Associates Ltd have the following insurances: Employers Liability - £10 million; Public Liability - £5 million; Products Liability - £5 million; Professional Indemnity - £100 thousand.

Personal property is not covered by our insurance policy and participants are advised to obtain their own insurance cover if this is appropriate.

Supervision

Levels of supervision will vary according to the activity and competence of the group. In some circumstances it will not be possible for the instructor to provide direct supervision at all times.

Emergencies

In the event of an emergency the supervisor may make an emergency decision on the participant's behalf, including permission for medical treatment following an injury or in line with information disclosed on the consent form.

Behaviour

Participants must behave responsibly and follow advice and safety instructions. Individuals will be withdrawn or the event suspended or cancelled where unacceptable behaviour is deemed to pose a danger to the individual or others.

Physical fitness

Participants are responsible for ensuring they are fit and able to undertake training. There may be occasions where participants are assessed as unfit to continue participation and will be withdrawn by the instructor if there is an unacceptable risk to their safety or wellbeing or to the safety or wellbeing of others.
