When thinking about your risk assessment, remember:

A hazard is anything that may cause harm, such as chemicals, electricity, working from ladders, an open drawer

The **risk** is the chance, great or small, that someone will be harmed by the hazard.

There are five steps in the risk assessment process:-

- 1. Identify the hazards.
- 2. Decide who might be harmed and how.
- 3. Evaluate the risks arising from the hazards and decide whether existing precautions are adequate or more should be done.
- 4. Record your findings. www.essex-aikido.org uses a standard format for all risk assessments.
- 5. Review your assessment from time to time and revise it when necessary. If any significant additional measures are required, review the assessment again when they have been implemented.
