

ABOUT YOUR WEDDING & MARRIAGE

LEGAL REQUIREMENTS

The Federal Government has certain requirements for couples intending to marry. The wedding must be conducted by an authorized celebrant. A *Notice of intended Marriage* form must be completed and lodged no later than a month, and not earlier than 18 months before the wedding date. You are required to provide *Birth Certificates*, and to sign the *Church Register* and the *Marriage Certificate*.

ORDER OF SERVICE LEAFLETS

An attractive Order of Service will enable your guests to follow the wedding service and provide a memento for you and your guests. If you are planning to print an order of service, please discuss this with the minister BEFORE printing. He will provide an outline of the official wedding ceremony.

FLOWERS & PEW-END DISPLAYS

Flowers are permanently in the church. If you require special flowers, they are purchased by the couple and arranged by you. Pew-end displays are not to be stuck to the pews but rather tied.

PHOTOS/VIDEOS

You are welcome to commemorate your wedding with photos and/or a video, and we encourage you to consult with the minister to allow this to happen without disturbing the flow of your service.

CONFETTI/RICE/ROSE PETALS

Not to be thrown in the church
