By signing below you agree to allow **BeginAgains 4 Kids** to sell your items on consignment. You will be paid 40% of the selling price for items priced below \$100, and 50% for items priced above \$100. Your items will be displayed for 90 days. If you choose to pull your items **before** the 90 days expire there will be a \$10 fee due upon pick up. You must give us a minimum 3 days' notice prior to pick up. \_\_\_\_\_ (Initial)

If your items have not sold after 60 days, our policy is to discount them by 50% to encourage their sale. You may choose to not discount your items. Please indicate your choice below:

**Yes!** \_\_\_\_\_ I want my items to go 50% off after 60 days. **No!** \_\_\_\_\_ Please do not mark down my items after 60 days.

Items unsold after 90 days may be pulled from the sales floor. Items may be displayed for another 30 days at the sole discretion of BeginAgains 4 Kids. Clothing and small items, including toys, will not be returned to consignors. These items will be donated to local charities, churches, or families in need. The choice of recipient is at our discretion.

For items other than clothes, small items, and toys not sold after 90 days, please choose one of the following:

\_\_\_\_\_ Your unsold items will be returned to you. You will receive a call or an email when your items are ready to be picked up. Any items not picked up after **7 days** will become the property of BeginAgains 4 Kids and will be donated.

You agree to absolve BeginAgains 4 Kids and its owners, employees, or volunteers from any responsibility for theft, damage or loss of goods. We will do everything in our power to safeguard your items.

\_\_\_\_\_ (initial) I understand that in the event an item is found to have stains, rips, tears, or other damage after it is processed, it may be marked as "Damaged" on my account and it will be disposed of accordingly.

The attached sheet entitled "Consignment Information & Store Policies", dated 6/22/17 is expressly included in this agreement. BeginAgains 4 Kids reserves the right to change these policies at any time. We will not change any of the terms above, including consignor payment percentages, consignment periods, discount terms, or the disposition of unsold items without your prior consent.
