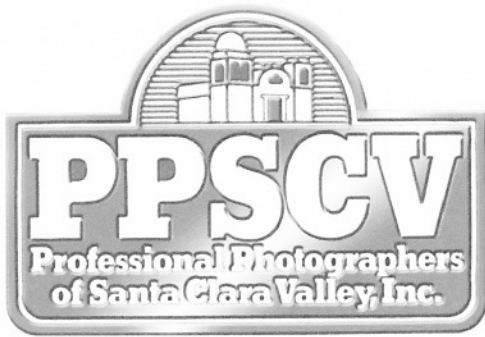
I will show a friendly spirit of cooperation to my fellow professional photographers and assist them whenever possible should they be in trouble or difficulty.

Membership Application

MEMBERSHIP CATEGORIES

ACTIVE PROFESSIONAL

An individual who, on a regular basis, takes and sells photographs for profit. Must satisfy federal, state, and local license requirements.

SERVICE SPECIALIST

An individual who provides handcraft services to the photographer.

STUDIO STAFF

An individual who is an employee of a photography studio.

SUSTAINING / STAFF

Manufacturers and distributors of photographic equipment, laboratories, publishers, or other firms providing services to photographers.

ASPIRING

An individual engaged in a primary occupation other than photography, but who is aspiring to become an Active Professional Photographer. Membership in this classification has a time limit of two (2) years, at which time a reevaluation of business status by the PPSCV Board of Directors is required.

Classification Rights.

Classifications of Active Professional, Studio Staff, Service Specialist, Retired, and Honorary may display the official emblem of PPSCV and have voting rights.

The classification of Aspiring does not have voting rights and may not display the official emblem of PPSCV. However, they do have access to other member benefits.

The classification of Sustaining has the right to display the PPSCV official emblem, but does not have voting right.
