UNDERDOG WRESTLING CLUB CODE OF CONDUCT

The Underdog Wrestling Club membership, board members and coaches have put forth great effort to develop a club of which we can all be proud. Great time and commitment has gone into establishing a strong foundation with solid beliefs and core values. How we conduct ourselves on and off the mat reflects on the participant and our Club. We always want to have respect.

Parent/Guardian Pledge - As an Underdog Wrestling Club parent, I acknowledge that I'm a role model and remember that athletics are experiences for kids that provide them positive traits to guide them through life. I will provide positive behavior, support, and encouragement, especially at "mat side." I will support the coaches and work to extend their teachings while upholding the club values. I will show respect for all other wrestlers, coaches, referees and spectators. I will never approach an opposing wrestler, coach, or referee without showing them respect. I understand what I say and what I do reflects directly on my wrestler, the club, and myself.

I realize and understand that if I violate this pledge I will be subject to disciplinary action. The 1st offense will be handled with a discussion and warning (Determined by Coach). The 2nd offense will result in a 2-week suspension from being mat side during your Child's match or from practice (Determined by Coach & Club Vice President). The 3rd offense will result in the remainder of the year suspension from being mat side during your Child's match or from practice. (Approved by Board)

WRESTLER'S PLEDGE - As a Club member, I acknowledge that I represent the Underdog Wrestling Club and the local community. I understand that wrestling and other athletic activities teach me sportsmanship, self-discipline, and confidence; Traits that will last me a lifetime. I will respect my teammates on and off the mat. I will strive to be the best partner that I can be at all times. I will never purposely try to harm my teammates or opponents. I will respect the coaches and practice facility by not running around or goofing off before or after practice. I will show respect for all other wrestlers, coaches, referees and spectators. I will shake hands after every match in a respectful manner. I will participate by the rules of the sport and exhibit good sportsmanship at all times. I will always strive to perform at my best.

Not all violations are the same, therefore it is important to note that the discipline will fit the violation. I realize and understand that if I violate this Pledge or Policy I will be subject to disciplinary action. The 1st offense will typically be handled with a discussion and oral warning. After multiple discussions for minor offenses the wrestler and parent will be informed that the next offense will count move to the next level (Determined by Coach). The 2nd offense will result in a formal written warning (Determined by the Coach). The 3rd offense will result in a 1-week suspension from practice (Determined by Coach & Vice President). The 4th offense will result in expulsion from the club (Determined by Board).

I have read and accept this Code of Conduct. I recognize that this Code of Conduct does not establish a complete set of rules for appropriate behavior, or provide the total spectrum of consequences for violation of these rules.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT WITH PARENTAL CONTENT ("AGREEMENT") AND MINOR RELEASE

IN CONSIDERATION of being permitted to participate in any way in any event ("Activity") at any time during the current calendar year I/we, the parents of the above named candidate to a position on the Underdog Wrestling Club, for myself/ourselves, my/our personal representatives, assigns, heirs, and next of kin, hereby give my/our approval to participate in any and all Underdog Wrestling Club activities, including transportation to and from activities.

1. ACKNOWLEDGE, agree, and represent that I understand the nature of the Activity and that the candidate is qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if, at any time, I believe the conditions to be unsafe, the candidate will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that: (a) THIS ACTIVITY INVOLVES RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("Risks"); (b) these Risks and dangers may be caused by the candidate's own actions or inactions, the actions or inactions of others participating in the Activity, the conditions in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS or SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of the candidate's participation in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the Underdog Wrestling Club, the sanctioning organization(s), their administrators, directors, agents, officers, members, volunteers, and employees, other participants, officials, rescue personnel, sponsors, advertisers, owners and lessees of Premises on which the Activity is conducted, (each of the forgoing shall be considered one of the RELEASEES herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED, OR ALLEGED TO BE CAUSED, IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may be incurred as the result of such claim.

AND I/WE, THE MINOR'S PARENT AND/OR LEGAL GUARDIAN, UNDERSTAND THE NATURE OF THE ACTIVITY AND THE MINOR'S EXPERIENCE AND CAPABILITIES AND BELIEVE THE MINOR TO BE QUALIFIED, IN GOOD HEALTH, AND IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN SUCH ACTIVITY. I HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS EACH OF THE RELEASEE'S FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON THE MINOR'S ACCOUNT CAUSED, OR ALLEGED TO BE CAUSED, IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND FURTHER AGREE THAT IF, DESPITE THIS RELEASE, I/WE, THE MINOR, OR ANYONE ON THE MINOR'S BEHALF MAKES A CLAIMS AGAINST ANY OF THE RELEASEES NAMED ABOVE, I/WE WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, DAMAGE, OR ANY COST THAT MAY OCCUR AS A RESULT OF ANY SUCH CLAIM, EXCEPT TO THE EXTENT AND IN THE AMOUNT COVERED BY ACCIDENT OR LIABILITY INSURANCE.
