Baird of Pueblo passed away 27 March 2017. He joined the Marine Corps in 1942, serving in the South Pacific during WWII and, was awarded the Purple Heart for wounds received in action. He was stationed at Camp Pendleton during the Korean War. Services will be held Saturday April 29th at 1030 at Christ The King Catholic Church in Pueblo. There was a service for Marine Paul Pack 18 April at the First Baptist Church in Colorado Springs. While in the Marine Corps he dreamed of flying and, eventually served as a pilot for the Civil Air Patrol. On 08 April, Jr. Past Commandant Russ Miller and I traveled to Westcliffe, CO to attend a service for WWII Marine John D. Martin. John saw action on Bougainville during WWII. He later enlisted in the United States Army and retired as a Sergeant Major. JoAnn Hinojosa, wife of Commandant Paul Hinojosa, lost her father Sam Moreno in April. They went to San Antonio, TX to be with family and friends and, attend the service.
