Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement ("Agreement")

PLEASE READ THOROUGHLY AND PROVIDE YOUR SIGNATURE

1. IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin:
2. ACKNOWLEDGE, agree, and represent that I and/or minor child understand the nature of Table Tennis Activities and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or minor child will immediately discontinue further participation in the Activity.
3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or minor child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or minor child incur as a result of my participation in the Activity.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS OR FASTT, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

This release is effective for the period of December 14, 15, 16, 17, 18, & 19, 2015. I swear and affirm that I am in good physical condition and I am not aware of any previous or existing diseases or injury that would result in my being injured. I further acknowledge that I have procured on my own and currently hold valid and adequate insurance for such loss, damage, or injury and if I do not have valid and adequate insurance, I accept full responsibility for the cost of the loss, damage, or injury that might occur as a result of my participation in the 2015 US Table Tennis National Championships. I give my consent to participate in any and all emergency transportation associated with activities during the 2015 US Table Tennis National Championships, in the event I become incapacitated or otherwise not conscious to give direct consent and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.

Deadline:

Early Bird Entry Deadline for the 2015 U.S. Nationals is Saturday, October 31, 2015. Event fees increase \$10 per event as of 11/1/2015. Final Entry Deadline – Entries postmarked after November 15, 2015 WILL NOT BE ACCEPTED. THE FINAL ENTRY DEADLINE WILL NOT BE EXTENDED!.

Eligibility:

Entries are limited to active USATT members as follows:

National Championships Events: Events 1-46 – U.S. Citizens-Proof of Citizenship must be submitted with the entry form.

Cadet and Junior National Championships Events

*Cadet Boys'/Girls' (Team Trials) - Born on or after January 1, 2001

*Junior Boys'/Girls' (Team Trials) - Born on or after January 1, 1998

Cadet and Juniors Team Trials - See separate entry form and prospectus for more information.

Minicadet National Championships Events (Events 6 and 7)

Minicadet Boys'/Girls' – Born on or after January 1, 2003

Championship Hardbat, Sandpaper, and Rating Events (Events 47-89)

For All Above Events Please contact USATT Headquarters (719-866-4583) regarding eligibility questions

Membership:

USATT Memberships must be valid through December 31, 2015. Non-members or expired memberships must enclose membership fee with their entry forms.

Rules:

The 2015 USA Table Tennis Nationals will be conducted under the USATT Rules of Table Tennis. All decisions by the Tournament Committee will be final and contestants upon entering agree to abide by them.

Equipment:

Tables and nets: JOOLA. Balls: Nittaku Premium 40+ (White). Floor: Two surfaces – rubberized floor and concrete. This is the *Official Approved Equipment* for the 2015 USA Table Tennis National Championships. **“Rackets in all events are subject to random testing for volatile organic compounds (VOC's). Any glues containing VOC's will cause the racket to fail.” EXCEPT FOR HARDBAT AND SANDPAPER EVENT'S, RACKETS MUST COMPLY WITH THE RED/BLACK RULE.**

Clothing:

The USATT Dress Code will be enforced. No white clothing will be allowed. Players must wear the assigned number or their name on the back of their shirt when competing. Names must be large and visible to spectators. It is recommended that each player come to the table with 2 distinctively different colored shirts

Entries:

Players may enter a maximum of 10 events but may not enter two events starting at the same time. **RATING EVENTS:** Players may enter any and all rating-restricted events they are eligible for based on their rating as of 10/1/15.

If two events with the same start time are entered, the player will have to decide which event they wish to participate in. Tournament Committee will choose on behalf of the player which event is to be played if the player could not be reached by phone and/or email.

RATING DOUBLES EVENTS: Players MUST be rated under 2500 to participate in the U4200 Doubles, under 2250 to participate in the U3700 Doubles, under 2000 to participate in U3200 Doubles, and under 1600 to participate in U2700 Doubles.

Rating Adult and Junior Events: Players entering the Rating Junior events must be born on or after 1/1/1998 (17 and under). Players entering the Rating Adult events must be born on or before 12/31/1997 (18 and over).

Doubles Partners:

Players **MUST** enter with a partner in all doubles events. **USA Table Tennis will NOT arrange for a doubles partner.** USATT can not be responsible for the non-participation of your selected Doubles Partner. It is the responsibility of the players to contact his/her doubles partner about participating in the event. No refund will be given for an event if a partner is not available. Players without a rating at the Qualification time can't enter rating doubles events. Partners withdrawing by November 30, 2015 may be replaced provided the replacement partner has a lower rating than the original partner. Partners withdrawing after November 30, 2015 may not be replaced. Need a doubles partner? Head to <http://www.teamusa.org/USA-Table-Tennis/Forum> and create a post requesting one!

Special Note: No change in addition or deletion of events or refund of event fees except for Doubles events (see Doubles Partners) will be allowed after the deadline of November 15, 2015. For all Doubles events the prize money is for the entire doubles team NOT per person.

Age Restrictions:

Players assume the responsibility of entering the appropriate age events. Players who are over/under the age limit of an event will automatically be entered in the correct age event.

Rating Restrictions and Seeding:

For rating eligibility (qualification), the ratings list as of 10/1/2015 will be used. This can be found at <http://tinyurl.com/2015USNationals> For draw and seeding purposes, the most recent USATT ratings list as of 11/19/2015 will be used. Players assume the responsibility of entering the proper events. Player that are over the rating limit of an event will automatically be entered in the next event. Players may obtain their ratings by contacting USA Table Tennis via email at admin@usatt.org. As a result of later seeding, some players may have ratings higher than shown for the event.

Unrated Players: (players without USATT rating):

Players may enter any championship event for which they are otherwise eligible. Players who are unrated on the seeding date (11/19/2015) will not advance to the single elimination stage of rating-restricted RR events. Players who enter a rating-restricted event without a rating and who acquire a rating between the qualification cutoff (10/1/2015) and the seeding (11/19/2015) will be permitted to advance provided their new rating meets the event's requirements. Unrated players are not permitted to enter rating-restricted singles events.

Matches:

All matches at the 2015 USA Table Tennis Championships will utilize 11-point game rules with the exception of Hardbat and Sandpaper events (see Hardbat and Sandpaper info). Men's and Women's Championship events will be best of seven (11-point games) from the round of 32. All RR events will be the best of five (11-point games). All other events will be the best of five (11-point games), single elimination, unless otherwise indicated.

Event Scheduling:

Events are not guaranteed to be completed on the same day that they begin. No refunds will be given for early departure. All events will be completed by Saturday evening. The Men's and Women's Singles finals are tentatively scheduled for Saturday, December 19.

Any event may be cancelled and the entry fee for that one event refunded if the event contains less than four players or pairs, as appropriate. In the case of event conflicts, the player is responsible for notifying the Control Desk as soon as possible. In case of an inadvertent error, liability is limited to the refund of the event fee for the event(s) involved.

Each event will begin on the date/time designated on the form, and it will continue at regular intervals until a champion has been determined. An entrant's signature on the tournament entry form acknowledges that the dates are acceptable for participation in the registered events regardless of any holidays, federal, state, local, religious, or foreign.

Championship Age Events:

Players must be over 30, 40, 50, 60, 70, 75, 80 and 85 as of December 31, 2015. Players for U-10 Boys and Girls must be born on or after January 1, 2005. Players in the 21 & Under Men's and Women's Singles must be born on or after January 1, 1994. **Proof of age must be readily available at the tournament.**

Withdrawal/Refunds:

A \$45 processing fee will be charged to any participant who withdraws from the tournament prior to November 15, 2015. **There will be no refunds after this date.** Withdrawal notification must be **in writing** at USATT Headquarters in order to receive a refund. **There will be no refunds given after this date except for injured players with a signed doctor's note.**

PLAYING FORMATS:

Junior and Cadet National Championship Events:

Junior and Cadet Singles are the Trials for 2016 National Teams. For the playing format for these events see entry form and 2016 selection procedure for Cadet and Junior Teams.

Minicadet National Championship Events:

Top 4 finishers in these events will qualify as members of the 2016 USA Minicadet National Team and will be considered for international Events based on USATT budget availability and invitations received.

The Playing format for these events will be based on number of entries.

First stage – Round Robin groups and Second stage – Single elimination. All matches will be played best of five games.

Junior Boys' and Girls' Teams:

The USATT club must send an email to admin@usatt.org with Club name along with names of the Team Players. The Junior Teams will not be accepted without Club approval. The Club along with the Names of the Teammates must be listed on the entry form. Playing system: Corbillon Cup System: 4 singles and 1

doubles, A-X, B-Y. Doubles, A-Y, B-X. Playing system will be Single Elimination or Round Robin depending on number of entries.

Men's and Women's Singles Championship Events:

In the men's singles, the top 16 players will be seeded into the main draw of 64 players. In women's singles, the top 8 players will be seeded into the main draw of 32 players. Depending on the number of entries, all other players will be drawn into qualification RR groups to advance into the main draw. The main draw will be played in a singles elimination format. All matches from the round of 32 will be played best of seven games. All other matches will be played best of five games. Men's and Women's Team Trials will be held at a different date and time Sunday and Monday December 20 and 21.

USATT/FASTT National Championship Sandpaper Event:

This event is co-sanctioned by USATT and Federal Association of Sandpaper Table Tennis (FASTT). All players entering the USATT/FASTT Sandpaper National Championships event must be an **active FASTT Pro members or purchase a FASTT Pro membership** during tournament registration. This membership is required in addition to the normal USATT membership that is required to compete in the 2015 US Nationals. The same rules as Hardbat (see below) will apply except the equipment will be an all wood blade with a sandpaper only cover on the playing surface. All players must be US Citizens and proof must be submitted with the entry form. 38mm balls will be used. Quarterfinals through Final will be 3 out of 5, 21 point games; all other matches will be 2 out of 3. USATT ratings will be used for seeding however results will only affect FASTT rankings. More information can be found at www.ttProTour.com. Prize money was donated by FASTT. **Event 88** - To qualify for the U1700 Sandpaper RR Singles event, your USATT rating will be used. First time unrated players with non-rating of any kind may enter this event. For the draw your rating must be under 1700 by the rating cutoff date of 10/1/2015.

Hardbat Events:

Hardbat rules, as adopted by the USATT Classic Table Tennis Committee, will be used for all hardbat events. See www.hardbat.com for the complete list of official rules. As in all events, a question of racquet legality is the decision of the Tournament Referee. Rackets complying with all requirements of the rules for hardbat rackets shall be legal. These events do not count for USATT ratings points. Eligibility for the hardbat rating events will be determined by the player's hardbat rating. However, draws for the hardbat events will be conducted on the basis of the ratings maintained by the hardbat Committee. If the participant enters the U-2000 hardbat RR, U-1800 hardbat RR, or U-1500 hardbat RR and there are insufficient entries, he/she will automatically be moved into the U-2000 RR, U-1800 RR, or U-1500 RR, if eligible. All hardbat matches will be played to 21-point games. All matches will be the best of 3 games, except for hardbat singles, where the quarterfinals, semifinals, and final will be best of 5 games. Balls: Nittaku Premium 40+ (White)

Registration:

Players must register with tournament officials at least 30 minutes before their first match and be ready to play each match 10 minutes before the scheduled starting time. See "Earliest Starting Times" in the *Schedule of Events*.

Publications:

Display and/or distribution of any brochures, posters, literature, or written material at the tournament venue is strictly prohibited unless previously approved by USA Table Tennis.

General Admission/Final Tickets:

Players will receive free entry for the entire tournament when they check in for registration in their player packet. Additional tickets may be purchased.

General Admission – Monday thru Saturday (does not include Semi/Finals) \$10/ day.

Tournament Pass: 6 Day Pass (Does NOT include entrance to Finals)

W/entry: \$30 | On site: \$35

Finals Tickets: Players and Tournament Pass holders receive \$10 off Finals ticket prices.
