## MINUTES OF MEETING

## MAY $9^{TH}$ , 2018

Topic: We have \$500.00 left in the street sign budget. Question asked to look into replacing our stop signs and speed bumps signs with reflective

signs. Think the speed bump signs would be more valuable. Jerry to look into. Mike Yeagle stated stop signs are in good shape except end of Tiffin St. Buckeye Tree update, between Mike Yeagle and Ray Mathews. Issue is waiting for harder ground to be able to work.

Boat Ramp Dock: Had budget okayed for \$37,000. Looking into two quotes. Given same measurements. Any discussion or questions on this? Note Price subject to change with steel fluctuation. Buy and hold now and store steel till job could be done. If board agrees will call tomorrow and go with his estimate and pre buy the steel. Motioned to go ahead with Wadsworth. First by Ray Mathews, seconded by Jerry Heminger. All in favor, Aye.

Old Business: None

New Business: Mike Yeagle talked to owners at corner of Columbus and Fostoria about their trees. They like their trees and want them to shield between the street and the house. Would like to have them trim them back a little. Will talk to them and see what remedy can be taken. Sight of traffic is an issue.

Robert Arth 2845 Cleveland St. Want to move existing shed from dock to road area. Add on to the dock and add gravel. Had drawings of said projects. Questions discussed about issues and all concerns. Will need final drawings for the file. Tom Geisbuhler asked any other new business. Nick Bartkiw stated about the garage sale asking Mike Luke about taking out an ad in newspaper. I stated that I put the ad in the paper. Took over from Carolynn Snyder. Doing that tomorrow.

Tom Geisbuhler mentioned that a member who lives on Toledo St. sends two to three e-mails a week to both he and Jerry Heminger. Board did approve that the people who live on Toledo to do their own landscaping on the middle island. This member is not happy with the work not getting done in his time frame. Discussed continuously about this matter. If there is still an issue that needs to be addressed then it needs to be put in the budget for next year. Nick stated you can get rocks free but have to go pick up. Will get solved eventually.

Bob Young asked whether we are sending out the Deed Restrictions to all others who were not at the annual meeting. Stated we should send out the draft. Letters for golf carts and dogs sent at the same time. Final mailed along with the

ballots. Other suggestions sending the golf cart, hunting, and dogs restrictions letters out separate from the deed restrictions.

Asked about the property (trailer) on Cleveland and Clyde. Needs work on that property. Will look up who lives there to contact. Asked any other new business.
