## **Coaching Code of Conduct:**

- 1) The use of tobacco, alcohol or drugs is prohibited while coaching kids on the playing field.
- 2) I will maintain disciplinary control of my players at all times that they are under my jurisdiction.
- 3) I will address officials in a respectful manner and accept all judgment calls as final.
- 4) I will abide by all WYSR rules and regulations, I will also abide by all the rules and regulations of the respective travel leagues and organizations that we participate with and enforce all provisions set forth by WYSR & all involved organizations.
- 5) I will set a definite example of sportsmanlike conduct for the players to emulate regarding officials, opponents, teammates and spectators.
- 6) I will conduct myself toward opposing players as they would towards my own players.
- 7) I will maintain control of spectators without denying the spectators their right to sportsmanlike conduct; such as cheering, shouting positive comments, etc.
- 8) I will make certain that my players observe all the rules of good sportsmanship at all times, avoid bickering with officials, unsportsmanlike conduct toward opponents, and any unnecessary rough play that is likely to cause injury.
