

### **How Far In Advance Should I Book My Makeup Artist?**

I would personally recommend booking anywhere between 12 and 18 months prior to your Wedding to ensure you can secure your Wedding date.

### **Would You Recommend I Have A Trial?**

Absolutely, not only does it give us the opportunity to go over which look you would like to achieve it will also give us a chance to ensure the products are best suited to your skin type. It will also allow me to see if I may need to make any adjustments for on the day itself. The beauty of having a Trial is you will get the chance to wear the look all day and night to see how well it lasts and to also help you decide if you want to make any changes.

### **When Should My Trial Take Place And How Long Does It Last?**

I would normally recommend the Trial takes place 8-12 weeks before the Wedding day. The Trial tends to last between 1-2 hours depending on how many looks you would like to try. During our time together we can discuss your current skincare routine and if need be I can make some recommendations to add into your routine to ensure your skin is in the best possible condition come your big day.

### **Do My Bridesmaids Need To Have A Trial?**

This is completely optional, it is not a necessity but I do have some Bridesmaids who would like a Trial so they can see how they will look on the day, the Mother of the Bride can also book a Trial if they are unsure how they would like their makeup on the day.

### **Do You Offer Bridal Makeup Lessons?**

I do yes, if you have decided that you would like to do your own makeup on the day and would like to learn about the techniques to use and the best products for longevity and being photographed we can spend time together planning out your perfect look where you will come away feeling confident and fully prepared.

Lessons are also great if you are a destination Bride but would rather not pay for a Professional to travel out to you.

### **What Makeup Brands Do You Use?**

I use a variety of brands which deliver long lasting results and look beautiful on all skin types. I currently carry products from Chanel, Charlotte Tilbury, Dior, Guerlain, Clarins to name a few. Everything in my kit has been carefully selected to ensure it performs well and most importantly lasts day and night.

### **Can I Use My Own Makeup?**

If you would feel more comfortable using your own makeup that is absolutely fine, we will of course need to check that your products photograph well and do not cause any flashback issues. Please note that my prices will remain the same there will be no discount offered for my Professional kit not being used.

### **What Is The Maximum Number Of People You Can Do Makeup For?**

I can personally do makeup for 5-6 people however I do have a couple of Makeup Artist contacts who are not only reliable but are highly talented who would happily come on board to assist with further bridal party members. An assistant fee would apply to cover the cost of the additional artist.

### **What Are The Recommended Timings For The Wedding Party To Get Ready?**

I like to allow for 1 hour for the Brides makeup and 30-40 minutes per Bridesmaid and Mother of the Bride. I generally arrive 15 minutes prior to the agreed start time and ensure everyone is ready 45 minutes to 1 hour before you need to leave to allow enough time for you to get into your dresses and for everyone to have a relax before departing for the ceremony.

My preference will be to always do the Brides makeup last so it is nice and fresh.

### **What Does Your Price Include?**

I offer two bridal packages which both include the Brides Trial, Wedding Day makeup along with two Bridal Party Adults on the day. The second package also includes a Lash Lift for the Bride. Additional Bridal Party Members can be added on to the package.

Within both packages I provide an Exclusive Pamper Experience for the Bride which consists of a hydrating face mask, a soothing eye mask and lip treatment. 20 minutes would need to be factored in for your Pamper Experience which will commence directly before the makeup application.

A "Trial only" can be accommodated but please be aware that there will be no guarantee your Wedding date will still be available to book as dates are only secured on receipt of a non-refundable retainer fee, this is one of the reasons why I have provided a Bridal package.

### **How Long Will You Stay For On The Day?**

I will stay until you are ready to leave so that I can provide last minute lipstick touch ups, if you would like me to return later in the day or evening for a full touch up please do ask and I will be able to provide a price for this additional service.

### **Do You Supply A Touch Up Kit?**

I currently do not automatically offer this option however I would be more than happy to make recommendations of what you may require or I can happily source products to put into a touch up kit for an additional fee.

### **Do You Cater For Sensitive Skin?**

I do carry skincare and makeup for those who suffer with sensitive skin, please do let me know prior to your trial if you or any bridal party members do have sensitive skin so I can ensure I pack the relevant foundations I use for sensitive skin.

### **What Will Happen If You Cannot Make It On My Wedding Day?**

The only time where I would not be able to attend would be due to severe sickness in which case a replacement Makeup Artist would be sent but please feel confident that I will turn up for your Trial and Wedding Day, I pride myself on being Professional and letting people down is not something that sits lightly with me. You can 100% trust that I will turn up.

### **Should I Have My Hair Done Before My Makeup?**

I do recommend hair is carried out before the makeup the last thing you want is to feel hot and bothered whilst your stylist is using hot appliances, we want your makeup to be as fresh as possible prior to you leaving for your ceremony. But if you require makeup before your hair this can be accommodated, the day is about you and what you are comfortable with.

**Do You Charge A Travel Fee? How Far Do You Travel?**

I cover the first 20 miles free of charge however anything after this is charged at 45p per mile to and from the location of where you will be having your Trial and also where you will be getting ready on your Wedding Day.

**How Do I Secure My Wedding Date?**

As part of my terms and conditions I ask for a £75.00 non-refundable retainer fee to secure your date, this will ensure that I can turn away other enquiries for the same date. The retainer fee will be deductible off the final cost. Payment will be due within 3 working days of my invoice date.

The remainder of the cost will be due on the day of your trial.
