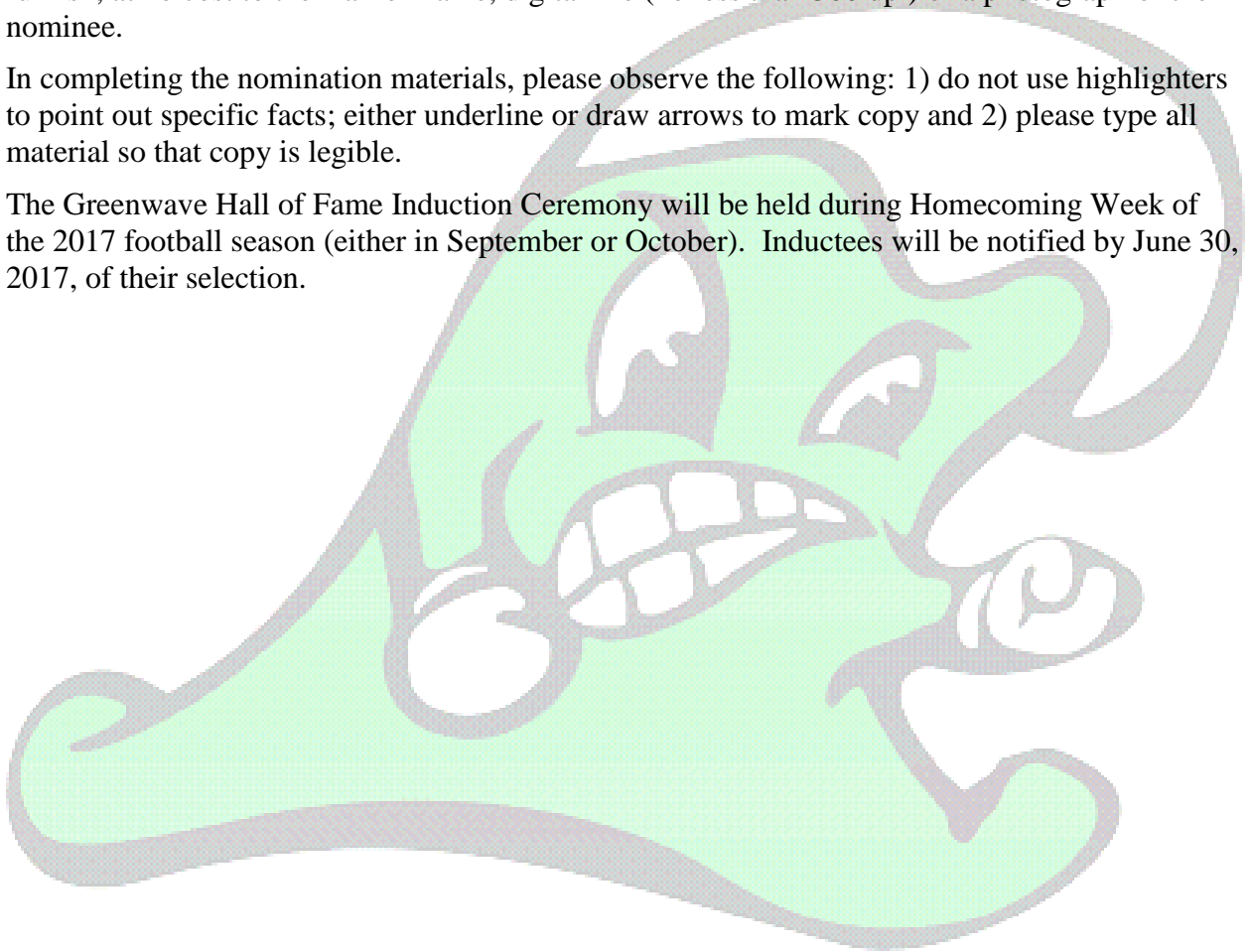
INSTRUCTIONS

All information on this form must be completed and received by May 31, 2017, for the candidate to be considered for the inaugural Class of 2017. The completed nomination form and support materials should be emailed to greenwavehalloffame@gmail.com. Once the nomination form is received by the Greenwave Hall of Fame Committee, all action necessary to the selection process shall remain confidential. All information submitted shall be retained by the Greenwave Hall of Fame.

A portrait-type and/or action photograph also should accompany this nomination. If the nominee is inducted into the Hall of Fame, the nominee or individual submitting the nomination shall furnish, at no cost to the Hall of Fame, digital file (no less than 300 dpi) of a photograph of the nominee.

In completing the nomination materials, please observe the following: 1) do not use highlighters to point out specific facts; either underline or draw arrows to mark copy and 2) please type all material so that copy is legible.

The Greenwave Hall of Fame Induction Ceremony will be held during Homecoming Week of the 2017 football season (either in September or October). Inductees will be notified by June 30, 2017, of their selection.

CRITERIA

Nominees must exemplify the highest standards of sportsmanship, ethical conduct and moral character.

The categories of athlete, coach, contributor and team are included on the nomination form for expediency in understanding the primary area in which an individual or team is to be considered for his or her achievements in interscholastic athletics. The grouping is for screening purposes only and to assist those making the nominations in understanding the type of information required. Once nominees are inducted, they are not categorized, but all are recognized as members of the Greenwave Hall of Fame.

All candidates for the Greenwave Hall of Fame must meet the following criteria to be considered for induction.

Athlete:

For athletes to be considered, a minimum of 10 years must have occurred since high school graduation. Athletes are considered as former student participants who are being nominated for their achievements in interscholastic athletics. Should have earned All-League, All-Region, All-State or All-American honors or own NFHS, NIAA, region or school records.

Coaches:

For coaches to be considered, a minimum of 5 years must have occurred since retirement from coaching in the sport(s) for being nominated. Coaches are considered on the merits of their high school coaching achievements only. Should have produced a career record above .500 and/or produced region championship teams or teams that have advanced to the region or state playoffs. Should have the recommendation of the athletics director at the time of his or her coaching career (if possible). Must have complied with NIAA rules while at Churchill County high schools.

Contributors:

For contributors to be considered, they are eligible immediately after retirement but must have a minimum of 15 years of contributions to that sport(s). Special consideration may be made on a case-by-case basis to honor and enshrine other staff members and supporters of the program who have made significant contributions by supporting, promoting or furthering athletics at Churchill County high schools in a non-coaching or non-playing role. The "Contributors" category is for those individuals who have made contributions to Churchill County athletics in some capacity other than those previously mentioned, including such areas as administration, boosters, officiating, sports medicine and sports media.

Team:

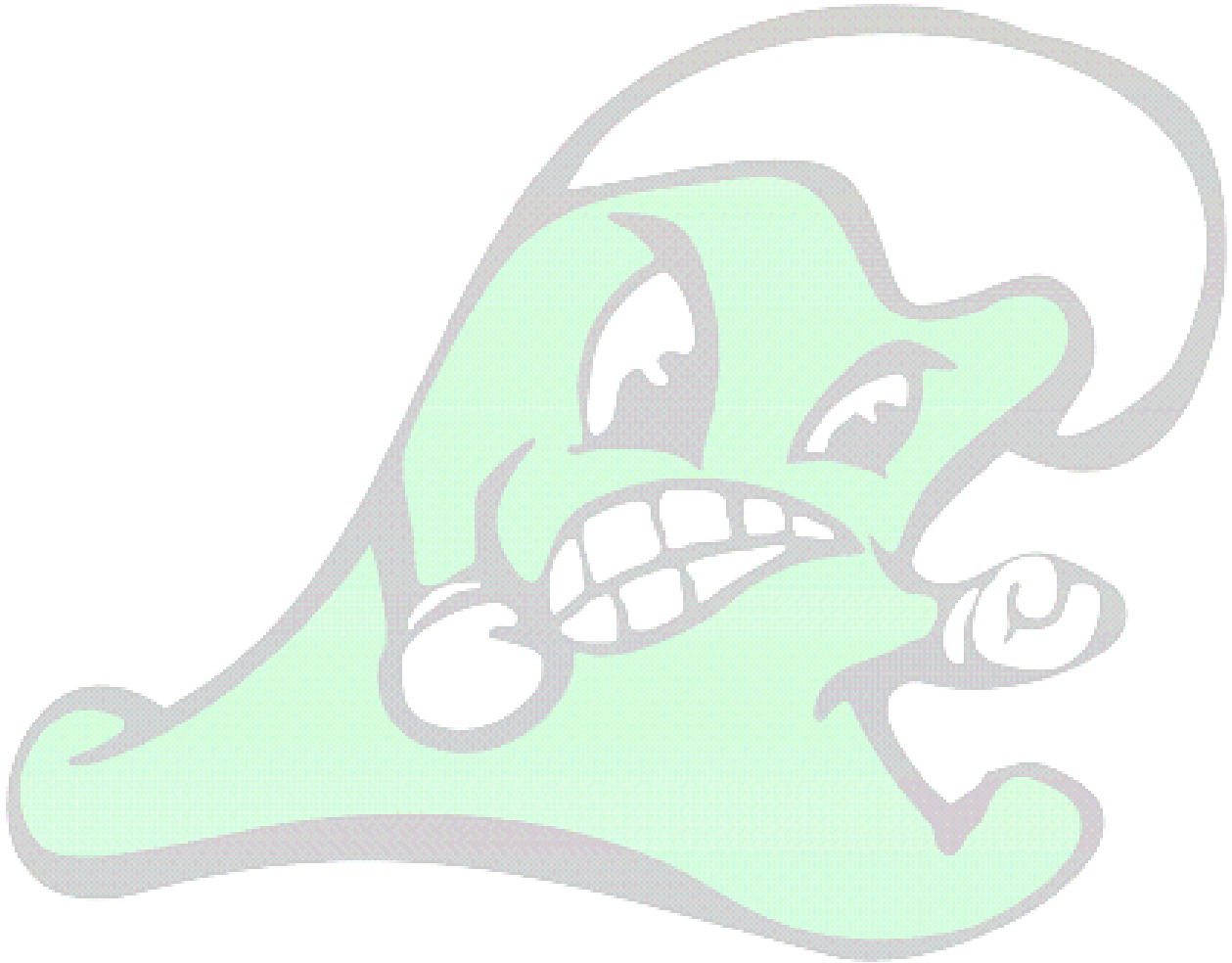
A minimum of 10 years must have occurred since achievement for which the team is being nominated. Teams consist of former student participants and are being nominated on the merits of their achievement. Only teams that won regional or state championships will be considered. Should have the recommendation of the coach (if possible).

Nominees for the Greenwave Hall of Fame will either be 1) Approved and sent to the Selection Committee, 2) Put on "Hold" or 3) Placed in the "Inactive" category. The "Hold for Future Consideration" category means a nominee may be considered again within 2 years for induction

and that additional information and supportive material would be helpful before future consideration. “Inactive” indicates that the nominee no longer will be considered for Hall of Fame induction until renominated. A 1-year waiting period is required before renomination.

The Greenwave Hall of Fame is organized as a means of recognizing the many individuals who have made extraordinary contributions and have had superb accomplishments within Churchill County. The Greenwave Hall of Fame honors the contributions and accomplishments of these individuals who are worthy of this recognition as examples for others to emulate.

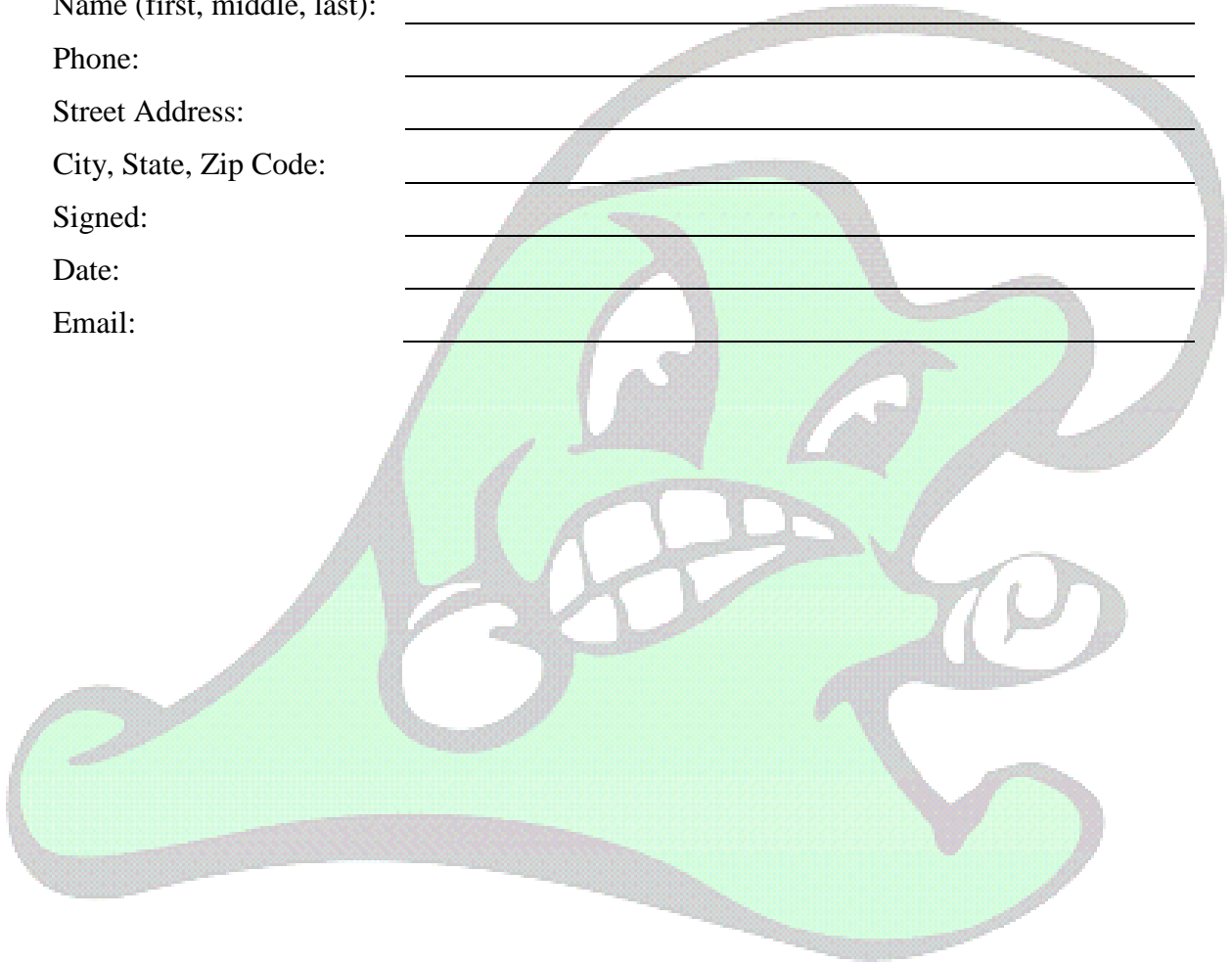
