1. Introduction

- 1.1 These terms and conditions govern your use of our website.
- 1.2 By using our website, you accept these terms and conditions in full; accordingly, if you disagree with these terms and conditions or any part of these terms and conditions, you must not use our website.
- 1.3 If you [register with our website, submit any material to our websites or use any of our websites services], we will ask you to expressly agree to these terms and conditions.
- 1.4 [You must be at least [18] years of age to use our website; and by using our websites or agreeing to these terms and conditions, you warrant and represent to us that you are at least [18] years of age.]
- 1.5 [Our websites uses cookies; by using our websites or agreeing to these terms and conditions, you consent to our use of cookies in accordance with the terms of our [privacy and cookies policy].]
