## Breeding Terms:

### Stud Fee: \$1800

The stud fee and stud contract, along with all bitch information and clearances, is due prior to breeding. Registration papers will not be signed without stud service and all vet expenses are paid in full. \_\_\_\_\_ (initial)

The total stud fee is \$1800. The bitch owner shall pay a \$300 non-refundable service fee before the mating takes place with the balance of \$1,500 due within 10 days post whelp. There is no free return mating if the bitch is not in whelp. If you choose to pay stud service in FULL (\$1800 up front), one free return stud fee will be provided within a 12 month period. \_\_\_\_\_(Initial)

All breedings are guaranteed to produce a litter. A litter shall be considered a litter, if at least two live (2) puppies are whelped. If the original stud is no longer available for service, the bitch owner may choose any other stud dog, with an equal stud fee, owned by Harbor Run. If the original bitch is no longer available to fulfill the breeding, another bitch may be substituted. There will be no refunds of stud fees or service fees.



The owner of the bitch will be responsible for any expenses pertaining to shipping dogs or chilled semen. These expenses include shipping kits, FedEx charges, Airline Counter to Counter, and shuttle service to the airport. These expenses are payable at the time of the breeding. The owner of the bitch will arrange for cooled semen shipping kits to be sent to Harbor Run prior to the breeding time. Bitch owner will reimburse/replace Harbor Run for any extenders that we provide. If the bitch is boarded for breeding with the stud dog owner/agent for the breeding Progesterone testing must be completed prior to arrival to ensure ovulation. If further progesterone testing is warranted to complete the breeding, tests are available for \$45. There will be

a \$30 day boarding fee charges during breeding dates. The bitch owner must provide current vaccine records, food, and any medical records needed for a successful breeding if boarding at Harbor Run. At the time of breeding, Harbor Run will provide the bitch owner with: a five generation pedigree of stud dog, copies of all health clearances to date, and a current negative Brucellosis screening (if live cover). Before breeding takes place, bitch owner will provide Harbor Run with the same information and paperwork of the above listed.

Accurate timing is the most critical factor in the success of breeding via shipped semen. Bitch owner is responsible for all testing done to the bitch prior to and during breeding to assure the proper timing of said breeding. All breeding will be done by artificial insemination. Bitch owner is responsible for the cost of said process if stud dog is not available for fresh collection. Please contact a good reproduction veterinarian for progesterone level testing. It is suggested that the owner of the bitch create their own FedEx account. It is very simple to do and facilitates shipping.

After a litter is whelped, breeder will send a completed AKC Litter Registration Form to Harbor Run for signature of the Owner of the Sire portion of the form. Harbor Run will then forward forms on to the AKC. If you prefer, a fast and easy way to complete a Litter Registration is online from the AKC Web site.

Puppies sired by Harbor Run dogs shall be sold on Limited Registration, unless solely owned or co-owned by bitch owner. In order to preserve the integrity of the pedigree, all puppies resulting from this breeding that are not retained by the bitch owner will be sold as companion dogs on non-

breeding AKC (or Country of origin) limited registration and must not be registered under an alternate registry for the purposes of breeding. Puppies shall not be sold to mass producing kennels or those that produce designer breeds or unrecognized coat colors.

Puppies resulting from the breeding may not be sold to brokers, pets shops, puppy mills, shall be used to produce cross breeds, such as, but not limited to Labradoodles, silver/designer colors or be used in puppy auctions. Should this part of the contract be ignored, the stud dog owner will pursue this clause in a court of law in place of residence of stud dog. Bitch owner will be responsible for five times the stud fee, if any puppies resulting from this litter are determined to be in such situations. Puppies are not to be sold outside of the country without written permission from Harbor Run, Heidi & Carolyn Kellerman.

\*\*\* I reserve the right to cancel a stud service at anytime through out the transaction if bitch owner does not agree to breeding terms.

I am in agreement with the above stud dog contract. Any other specifications warranted shall be listed on the back of this contract and initialed by both parties prior to breeding.
