POLICIES AND AGREEMENT

Your pet's safety and health is our number one priority at Pet Villa. By signing below, you agree that the following terms and conditions apply for all services provided at any time by Pet Villa:

1. All dogs must be healthy and up-to-date with vaccinations (Bordetella, Distemper, Rabies), and neutered/spayed (six months or older), as verified by Vet, and be a minimum of four months old to participate in Day Care or Boarding. You represent that your dog meets these criteria and can provide the appropriate documentation upon request.
2. You agree to notify us of any current medications, medical issues or injuries. In case of illness or injury, Pet Villa will perform first aid, and contact or transport your dog to a veterinarian, if necessary. You agree to be solely responsible for the payment of all medical bills for your dog and you release Pet Villa, its officers, directors, agents, volunteers, and employees from any and all responsibility for, or claims, damages, and/or debts, arising out of or related to such medical care including, but not limited to transportation to/from the medical provider and the choice of medical provider. Owners will be notified to pick-up pets found to have an illness, virus, parasite, or injury. Dogs with flea or tick problems will not be admitted and must seek vet aid. Pet Villa is not responsible for the transmission of diseases, viruses, parasites, etc., between pets.
3. Dogs must pass behavioral evaluation to participate in activities. Dogs must be friendly with people, and other dogs, not showing aggression or excessive fear. Pet Villa has the right to deny access to any pet based on the pet's ability to participate in activities with people or other dogs, or if ongoing behavior is deemed dangerous or unmanageable for any service offered at Pet Villa. Such decision will be made in Pet Villa's sole discretion.
4. Pet Villa reserves the right to immediately change your dog's type of Day Care or Boarding if we believe it is necessary to protect the health and well-being of your dog, other dogs, and/or our staff. Such decision will be made in Pet Villa's sole discretion.
5. You fully accept and assume all risks associated with your pet's participation at Pet Villa. You further agree to release, indemnify, and hold Pet Villa harmless from any and all claims, losses or damages arising out of or relating to the services provided by Pet Villa.
6. While being groomed, your pet is at risk of stress, trauma, and injury, especially if hair is severely matted. De-matting may cause hair loss. You consent to Pet Villa removing matted hair.
7. Cancellation policy: 24 hours for non-holiday appointment, 72 hours for all federal holiday reservations. If you do not cancel within the applicable prescribed time frame, you will be required to pay the full amount for the reservation or a deposit.
8. You release and grant Pet Villa all rights in any photography taken of your dog
