Please Note : Solo Choreography is the only division requiring to hand in their music. You are able to hand in your Music on the day, The Producer will not be able to check that music meets Official WSB Rules and Regulations on the event day. The Produce is able to check mixes if a copy is sent 3 days prior to competition via email. Regardless if mixes are or are not sent for checking All solo choreography competitors will be required to bring their final mix (on CD or USB) to their allocated stage rehearsal.

(Entry Forms & Fees received after this date & time will include a \$10 late fee per person – NO EXCEPTIONS)

1. **ENTRY fee: \$30.00 per member, per crew**
2. **JUNIOR Solos ONLY** are allowed one person back stage to manage them. The **Manager** of the junior Solo Competitor should sign pages 1 and 2 of this Registration Form. Manager needs to be over 18 years of age who is able to represent the Junior competitor with full knowledge about them.
3. **All Registration Forms must be sent in.** Please ensure you make a copy for your own records.
4. Registration Forms **must be sent via Post or Email.**
5. **ALL** dancers individually must complete and sign the **Dancer's Agreement, Discharge, Release, & indemnity Form** (Page 3 of Registration Forms). All participants under 18 years of age need a parent / guardian to sign in their behalf. **The waiver is for a 12 month term. Ideally Waiver forms and photo IDS must be handed in at sign in on the day with photo ID's.**
6. We MUST receive PAGE 3 & fees by the Entry Deadline stated above or you will incur a late fee.
7. **Crew Members Proof of Age Identification:** Each crew individual MUST present Passport / Drivers Licence / Birth Certificate to Registration Sign-In (ON THE DAY) of the Competition. *You may send IDENTIFICATION with Registration Forms and Fees.*
8. Please make sure the competitors names' listed on Registration Forms are the same as Photo ID that will be presented on the Competition day at Registration Sign-In.
9. Individuals who withdraw from the competition due to any given circumstances after registration forms and fees have been sent in, will not get refunded – NO EXCEPTIONS.
