

EQUINE ACTIVITY RELEASE AND HOLD HARMLESS AGREEMENT

1. I, the undersigned, have read and understand, and freely and voluntarily enter into this Release and Hold Harmless Agreement with Tamber Stables LLC, understanding that this Release and Hold Harmless Agreement is a waiver of any and all liability (ies).
2. I understand the potential dangers that I could incur in mounting, riding, walking, boarding, feeding said horse; including, but not limited to, any interactions with other horses, **as well as all outdoor / Indoor activities that may occur on the property**. Understanding those risks I hereby release Tamber Stables, LLC, it's officers, directors, shareholders, employees and anyone else directly or indirectly connected with Tamber Stables, LLC from any liability whatsoever in the event of injury or damage of any nature (or perhaps even death) to me or anyone else caused by or incidental to my electing to mount and ride a horse owned or operated by Tamber Stables, LLC.
3. I understand and recognize and warrant that this Release and Hold Harmless Agreement, is being voluntarily and intentionally signed and agreed to, and that in signing this Release and Hold Harmless Agreement I know and understand that this Release and Hold Harmless Agreement may further limit the liability of equine professionals to include any activity, whatsoever, involving an equine, including death, personal injury and/or damage to property.
4. I recognize and agree that I know which equine professional (s) I will be working with, and acknowledge that I agree said equine professional (s) has/have made reasonable efforts to determine my ability to engage in the equine activity, and has/have sufficient knowledge of my equine and horseback riding skills as to relieve, release and hold harmless said equine professional (s) from any continuing duty to monitor my equine activities.
5. I further voluntarily agree and warrant to Release and Hold Harmless this (these) equine professional (s) from any liability whatsoever, including, but not limited to, any incident caused by or related to said equine professional's (s') negligence, relating to injuries known, unknown, or otherwise not herein disclosed; including, but not limited to , injuries, death or property damage from: mounting; riding; dismounting; walking; grooming; feeding; use of horse barn, paddock, trails or horse ring, in any capacity; falling off horse whether horse is bucking, flipping, spooked, or my failure to understand any equine professional's directions relating to my riding or otherwise use and control, or lack thereof, of my horse or the horse I have been assigned to .

BARN RULES

1. Boarders and guests are to clean up after their horse/themselves.
2. All doors and gates in the arena are to be kept **CLOSED** at all times.
3. Trash is to be placed in the designated receptacles provided.
4. Unless you have an owner's permission **DO NOT** feed anyone's horse but your own.
5. **NO SMOKING** within 300 ft. of the barn. Cigarette butt littering **WILL NOT BE TOLERATED**.
6. Persons under the age of 18 must be supervised by an adult at all times.
7. Person under the age of 18 **MUST** wear a helmet. Protective vests are strongly recommended.
8. Parking is in designated areas only **RIGHT** sides of the barn leave room to drive by. **NO** parking in front or near the garage opening.

9. Driveway speed is not to exceed 10mph.
10. No Illegal drugs or alcohol permitted.
11. If you turn on a light, turn it off when you are finished in that area.
12. Barn hours are from 8am-9:30pm Sun-Thurs. and 8am-10:30pm Fri.-Sat.
13. Boarder and guest may **NOT** handle any equine other than their own or a horse that they have leased.
14. Do not ride on properties not designated as allowed riding areas. You are responsible for trespassing and the charges that may occur.
15. Dogs are **NOT** permitted on premises.
16. No running /yelling inside or outside of the barn. The barn is not responsible for any injury, accident, and/or death associated with scaring or spooking an equine due to inappropriate behavior or misbehavior.
17. All guests must sign the hold/harmless agreement and a copy of the barn rules prior to engaging in any equine activity.
18. All tack/equipment is to be kept in your locker/trailer/car when not in use.
19. Do not use any tack/equipment that is not yours unless you have the owner's permission.
20. Please respect our privacy and that of our neighbors. Do not ride within a hundred and fifty feet of any house. If you need to contact Rick or Jeni please text or call. Rick 412 721-0015. Jeni 412 848-7660. **Please no house visits.**
