The competition will include an interview, on-stage question, the traditional bathing suit competition and evening gown competition. You will have an interview with the judges (Interview Attire), on Saturday, September 22nd, 2018 at Dardanelle Community Center at 1:00 p.m. The pageant containing the bathing suit, evening gown, and onstage question portion of the competition will be held on Saturday evening at 6:00 p.m.

**The winner will move on to compete in the Mrs. Arkansas America Pageant on Saturday, November 10, 2018 at the Hot Springs Convention Center. Winner will receive \$300 cash prize plus a \$250 sponsorship to Mrs. Arkansas America. Winner is also asked to participate in our Christmas Parade on Friday, December 7th. You must provide your own transportation and sign for the parade. We also ask that you be at the Chamber of Commerce Chicken Fry at a date to be announced.**

For those who are interested there will be a "Mrs. Photogenic" contest with an additional entry fee of \$10.00. Additional photos may be entered at a cost of \$5.00 per photo. Photo's must be turned in by September 19th, and will be judged before the pageant. The Dardanelle Chamber of Commerce will not be responsible for lost, stolen or damaged photos, so you may want to turn in a copy of your photo.

There will not be a rehearsal this year. The walk this year will be very simple, (same as last year) so we will have time to go over it before the pageant. An outline of the walk can be found on our website, [missmtnebo.com](http://missmtnebo.com).

There will be bags set up for each contestant for voting for crowd favorite. The girl with the most money in her bag will receive the money in her bag and a trophy.

**RULES AND REGULATIONS**

1. Applicant must be married as of the date of entry and throughout the State and National Competitions.
2. Applicant is and always has been a female and is at least 18 years of age as of the date of entry.
3. Applicant will continue to be a person of good moral character; affirms that she has not committed and will not commit any act inconsistent with the highest standards of public morals and conventions or that will reflect unfavorably on the Pageant, its representatives, sponsors and or/licensees; that during her majority (18 years of age or older), she has not willingly appeared in provocative and sexually explicit photographs for any film, video, or publication prior to, during the Mrs. Mt. Nebo Pageant, the State Pageant, or during her reign as a State winner or as "Mrs America."
4. Applicant must be a U.S. Citizen and a resident of the "State", or "Military Installation", in the "State" of entrance into the Pageant. If Applicant seeks to represent the District of Columbia, she must reside in or work within a 25 mile radius, on a full time basis, thereof. Applicant is only permitted to enter one State Pageant per Pageant year, and must follow rules outlined above.
5. Applicant will attend the Mrs. Arkansas America if selected as the Winner and further abide by all the required services, rules and regulations governing this State Pageant. Applicant is responsible to Mrs. Mt Nebo, Mrs. America and her State Director in the event of non-compliance with the same.
6. Applicant may have a modeling, personal management and/or agency contract, which contract, however, does not include, authorize, or permit the use of the name of "Mrs. Mt Nebo," "Mrs. America Pageant" or any title designation or reference with respect to the Pageant in any manner. Applicant may not have any commercial tie-up or endorsement agreement or commitment of any kind whatsoever. Applicant agrees to be bound by the rules, regulations and the Contestant Agreement required by Mrs. Mt. Nebo and Mrs. America, Inc.
7. Director may accept a qualified Contestant, who has previously competed at the Mrs. Mt Nebo Pageant.
8. A Contestant may not participate as a contestant in another pageant for married women while holding a city, county, or State Title in the Mrs. America system.
9. Applicant hereby authorizes the use of any Pageant photos or video reproduction of the Applicant at the Mrs. Mt. Nebo or State Pageant for promotional purposes.
10. As consideration for this agreement, Contestant promises to pay the respective entry fee, all payments being non-refundable.
11. Failure of a Contestant to abide by the rules above may result in disqualification and or removal of a Title at the discretion of the Director, subject to review by the Pageant Committee.
