



**REGISTRATION FEE:** All participating artists must have their canvases stamped at the Arts Center. Registration fee is \$40 for all four (4) days, or \$15 per day. Artists may paint any number of days. **Payment must be received with the registration form for complete registration.** Artists registering two (2) or more days will receive one (1) free ticket to 'Que the Arts.

**SCHEDULE:** **Wednesday, May 1, 2019, 9:00 a.m.** – Meet at the Arts Center, 400 North Queen Street, for refreshments and registration. All panels will be stamped at this time. Each registrant will receive a welcome packet, which will include an area map. Artist registering for two (2) or more days will receive a free admission ticket (\$35 value) to 'Que the Arts – An Evening of Music & Art, the Arts Council's sponsored cocktail party, art show

and sale. This event is scheduled for Wednesday, May 1, from 6:00 p.m. to 9:00 p.m., at the home of *Kristin & Johnathan Hughes* located at 302 W. Atlantic Avenue. (Rain date is Thursday, May 2, 6:00 p.m. to 9:00 p.m. at the same location.)

**Thursday, May 2, 2019, 9:00 a.m.** – Registration at the Arts Center for new arrivals and canvases stamped; artists free to paint.

**Friday, May 3, 2019, 9:00 a.m.** – Registration at the Arts Center for new arrivals and canvases stamped; artists free to paint.

**Saturday, May 4, 2019, 9:00 a.m. to 3:00 p.m.** – Registration at the Arts Center for new arrivals and canvases stamped; artists free to paint. Artists submit work to the Arts Center by **4:00 p.m.** Up to four (4) event-stamped canvas paintings may be entered in judging. An artist's reception and judge's critic will begin at **4:00 p.m.** Public is welcome and encouraged to attend. Artists may also enter additional plein air paintings for the "wet paint" sale on display at the Arts Center. A commission will be charged on all works sold.

Canvasses/boards not stamped cannot be entered into the jurying process. A commentary by the juror with awards presentation and reception will be held at the Arts Center, 400 N. Queen Street, Kinston, NC, Saturday, May 4, 2019, at 4:00 p.m. A concurrent "wet paint" sale will be hosted at this time. This event is free and open to all artists and the public. A commission will be charged on all sales. Any paintings not sold at the "wet paint" sale may be left at the Arts Center for display through June 30, 2019. Artwork may be framed if so desired by the artist.
