**DEFINITIONS**

In this Release Agreement, the term "summer camp" shall include all activities, events, services or use of facilities provided, arranged, organized or conducted by the Releasees at The Wild Rumpus Camp including but not limited to: hiking, swimming, canoeing, kayaking, zip lining, boating, archery, team games, parties, relays, orientation and instructional courses, and all other related activities, events or services.

**ASSUMPTION OF RISK**

Injuries are a common part of summer camp. Summer camp at The Wild Rumpus takes place in a remote location surrounded by rugged wilderness and terrain that will expose the camper to many risks, dangers and hazards. These include but are not limited to: transportation by boat or motor vehicle, changing weather conditions, mechanical failure of equipment, slips, trips, falls, loss of balance, unmanned ocean front, cliffs, trees, wildlife, cuts, burns, negligent first aid, negligence of other persons, and **NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF SUMMER CAMP.**

Communication in the remote location may be difficult and in the event of an accident, rescue and medical treatment may not be readily available.

**I AM FULLY AWARE DRINKING ALCOHOL IMPAIRS MY ABILITY TO ACT SAFELY AND INCREASES MY CHANCES OF INJURY AT ALL TIMES.**

**I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH SUMMER CAMP AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.**

**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT**

In consideration of the Releasees agreeing to my participation in summer camp at The Wild Rumpus and my use of services, equipment and facilities, I hereby agree as follows:

- 1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Releasees TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury, including death, that I may suffer or that my next of kin may suffer, as a result of my participation at summer camp, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE ON THE PART OF THE RELEASEES.**
2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES for any and all liability for any property damage, loss or personal injury to any third party resulting from my participation at summer camp.
3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity.

In entering into this Release Agreement I am not relying on any oral or written representations or statements made by the Releasees with respect to the safety of summer camp, other than what is set forth in this Release Agreement.

**I CONFIRM THAT I HAVE READ AND UNDERSTOOD THIS RELEASE AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING THIS RELEASE AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I MAY HAVE AGAINST THE RELEASEES.**
