Patrons will be asked to cast their vote for \$1 each, and the team that earns the most "votes" wins. Teams are asked to provide approximately 100 lbs. of meat (any kind) for tastings. - *Must enter Ribs, Chicken categories to be considered for Grand Champion Awards. Alabama BBQ Association will only be awarding BBQ Trail points in these 2 divisions.
- 3. Fires shall be of wood, wood pellets or charcoal. Gas and electric heat sources shall not be permitted for cooking or holding. Electric is permitted as a fire starter, provided that the competition meat is not in/on the cooking device. Electrical accessories such as spits, augers, forced draft are permitted. No open pits or holes are permitted. Fires shall not be built on the ground.
- 4. Contestants shall provide all needed equipment and supplies. Safety at this event is paramount. Any unsafe acts or safety issues identified by the SBCF Rep will be immediately corrected. Failure to follow the directions of the SBCF Rep may cause removal from the grounds. Contestants must adhere to all fire and safety codes. A fire extinguisher shall be near all cooking devices.
- 5. All contestants must be in place by 9 a.m. on Saturday, March 17. Grounds will be open for contestants Friday, March 16 beginning at 9 a.m. for set-up of equipment.
