



Dear Miss Rodeo Minnesota Sweetheart Contestant and Family:

On behalf of the Miss Rodeo Minnesota Pageant, we would like to congratulate you on taking the first step towards becoming our Miss Rodeo Minnesota Sweetheart!

The 2019 pageant will be held in the summer of 2018 in conjunction with the Waconia rodeo (July 13-14th). As you begin the process of filling out the application, make sure you take your time and be thorough. The Miss Rodeo Minnesota Association (MRMNA) only wants you to do your absolute best. All applications are subject to approval by the MRMNA and the application deadline to be received is June 15, 2018. The Miss Rodeo Minnesota Association reserves the right to refuse any contestant application. If a contestant is refused entry in the contest, there will be no appeal process. Be sure to utilize the checklist included in the application to ensure you have completed all required paperwork.

A full break down of the schedule will be included with the acceptance letter, which will be sent within 5 days of receiving, and approval of, your application. Crowning of the 2019 queens will take place at the Saturday evening rodeo.

Western attire is required for pageant events, coronation, and rodeo events. Such attire may include: a button down or western style shirt, denim – pants or skirt, hat, boots, etc. Attire may be classic or fashion-forward western.

During pageant and rodeo activities, candidates will be judged on their ability to speak publicly with poise and confidence, as well as, hold a conversation, showcasing their personality and passion. Candidates will participate in an interview with the judges; questions will be based on the responses given within the application. Candidates will also be asked to introduce themselves and interact with rodeo attendees.

Candidates for Miss Rodeo Minnesota Sweetheart 2019 should be comfortable around horses and other rodeo stock. Horsemanship training and riding experience are preferred, but not required. If selected as Miss Sweetheart Rodeo Minnesota, you will be asked to attend a small number of rodeo events, but are unlikely to participate in riding activities during the events.
