



Dear Potential Miss Teen Rodeo Minnesota Contestant and Family:

On behalf of the Miss Rodeo Minnesota Association, we would like to congratulate you on taking the first step towards achieving your goal of becoming Miss Teen Rodeo Minnesota 2020. The 2020 pageant will be held in the summer of 2019 in conjunction with the Waconia rodeo (August 22-24, 2019). As you begin the process of filling out the application, make sure you take your time and be thorough. The Miss Rodeo Minnesota Association (MRMNA) only wants you to do your absolute best. All applications are subject to approval by the MRMNA and the application deadline to be received is July 15, 2019. The Miss Rodeo Minnesota Association reserves the right to refuse any contestant application. If a contestant is refused entry in the contest, there will be no appeal process. Be sure to utilize the checklist included in the application to ensure you have completed all required paperwork.

When you return your application be sure to include the following (address below):

1. Signed and notarized pageant application agreement
2. Entry fee of \$200 (check or money order payable to the Miss Rodeo Minnesota Association). **The entry fee will be reduced to \$150 if your application is received before June 15th.**
3. Electronic copies of your biography (not to exceed 150 words) and "Why I Want to be Miss Teen Rodeo Minnesota" (This must be in WORD format. Email below).
4. Copy of your birth certificate, driver's license, and proof of health insurance coverage.
5. Photo of yourself in western attire (can be traditional or fashion-forward), does not have to be from a professional photo but does need to be tastefully done and be a headshot.

Tentative clothing requirements will be: one (1) professional outfit for speeches; one (1) professional outfit for personal interviews; one (1) fashion-forward western dress outfits); two (2) rodeo attire outfits and one (1) horsemanship outfit (white button down western shirt and blue Wranglers required).

Acceptance letters and additional information will be sent within 5 days of receiving, and approval of, your application. Should you have any questions, please do not hesitate to contact us. We are looking forward to an exciting, fun-filled pageant this year and hope you will be part of it!
