Dear Member,

As of June 28, 2014 our commission shall be ten percent (10%) to list all Membership Sites. Enclosed is a Sales Office Listing Agreement or you may download it at [gbntone.org](http://gbntone.org). A Transfer Fee of \$600 is required to be paid by the buyer at the time of sale.

If you are listing a RV (trailer) with your membership, a copy of the RV Title, in listing member's name, must be forwarded with your Listing Agreement. If you are currently paying Snohomish County Personal Property Tax the following shall apply. Excise Tax must be paid at the time of the sale. If the RV will stay in place and not be moved as part of the sale, an excise document must be completed and an excise tax paid on the sale price. All property taxes to Snohomish County must be paid in full for the year. R.C.W. 82.45.080 places the responsibility for payment of the excise tax on the seller. The excise tax must be paid within thirty (30) days of the sale to avoid penalties. Excise forms are available in the Snohomish County Treasurer's Office or in the GBNT Office. The transfer cannot occur until the excise document is completed and the tax paid. Completion of an excise document records transfer of ownership. If the seller maintains legal ownership, it will allow the buyer to be listed as the registered owner while listing the seller as legal owner. This protects the interest of both seller and buyer. If a transfer of ownership by gift, marriage or divorce an excise document still needs to be completed to record transfer of ownership.

When the GBNT Office receives your completed Listing Agreement your membership Site shall have a Site Inspection. If your Site is in compliance and your account with GBNT is current your membership shall be listed.
