# Park Manager's Message

#### Hello Campers!

This has been one hard winter with weeks of freezing temperatures to snow up to 24 inches we got hit hard. And still more on the way. We did have some warning it was coming. Some members took a preventative action to prepare for it while others did not. Each site has a water standpipe or a shared standpipe to use. Standpipes that are hooked up and left on to RV's are the responsibility of the member's to prevent the standpipe from freezing and breaking. Members who have neglected to properly insulate their standpipe and it freezes and breaks will be charged for parts and labor to replace and repair.

This snow storm produced a lot of very moist and heavy snow, as members found out, by the collapse of overhead tree tarps, popups and RV awnings left out are being ripped, torn and just a pile of bent metal on campsites. With more snow to come please take the time to winterize your sites. Every year, put things in your out buildings, put up that popup, and secure that tree tarp because, as we've seen here the wind can come up and or snow. So, take time each year make a list on what to do. Also, don't forget to winterize your RV water lines as well. During this freeze we have seen a few RV's with water running out the doors.

Few things to keep in mind this year:

All hanging lighting is restricted to a maximum height of 12 feet and is required to be turned off when members leave the park this is effective Jan 1, 2019 (BOD 7/28/18)

When cleaning brush and limbs, if at all possible please take all debris to ballpark burn pile. But remember, NO lumber, furniture or garbage at all is allowed. Secure all trash and food waist inside to not attract bears or other animals. You are responsible to remove all garbage from GBNT.

All vehicles and trailers including RV's etc., must have current tabs on them.

All RV's shall be maintained in a reasonable fashion to create a good aesthetic appearance. Please wash off your roofs and sides and remove all the algae and dirt.

No member shall arbitrarily place anything in the shared greenbelt to suggest, create or give the impression of a division of greenbelt. Rows of rocks, fence or partitions are not allowed.

Let's keep improving GBNT each year.

### The Pea Patch

Have you ordered your seeds yet? Burpee. Territorial. Gurney's. Park. Catalogs are coming. Are you ordering tomato seeds or waiting to buy a plant?

All important questions because April 15th is the deadline for securing the pea patch from last year, and requesting a patch for the first time. If you worked a patch last year, you are on the spread sheet for the same plots. Please confirm on the PeaPatch Facebook or call. Summer will be here before we know it.

The deadline for beginning visi-

ble work on your quarter is May 15th. Pots are available near the compost and will qualify to keep your space if you are not staying at GBNT before May 15th.

Members on our waiting list are eager to work a quarter patch. In all fairness we need to confirm that you will make use of your patch again. If you own more than one site, you qualify for more than one quarter patch.

Are you interested in soil delivered? Previously we ordered from Bailey Family Compost at \$30 cubic yard picked up at the farm. A full-size pickup holds 2 yards, level full. One cubic yard covers 162 square feet, spread 2" deep.

They do not deliver to GBNT. We can request delivery of their excellent compost from Top Soil NW. Call Maxine Brink 425-830-5767 if you want to participate as a group.

### Treasurer

At the October 2018 open board meeting, the board voted to set dues at \$1,100 a year, which is an increase of \$25 a quarter. As dues are billed a quarter in advance, the statement due January 6, 2019 which covered dues for January -March 2019 should have included the increase. Unfortunately, this did not happen. In order to collect the correct amount of dues for 2019, the statements due April 6<sup>th</sup> will include a one-time charge of \$25 in addition to the quarterly dues of \$275. Thank you for your understanding.

As a reminder, you do not need to wait to receive your statement before making payments. Some members have found that making monthly payments works well for budgeting purposes, such as \$100 or \$125 a month per site depending on your use of electricity. If you do this, you will owe a smaller balance when your statement arrives. To make posting of payments easier, please be sure to include your site number on the check.
