<p><u>Overview of the course</u></p>	<ul style="list-style-type: none"> • This course is suitable for those who are spiritually active in practises i.e. Reiki, other certified energy healing modalities and/or Angelic Healing, with a basic to advanced understanding of the human energy systems and the twelve physical systems of the body.
<p><u>Prerequisites for Course enrolments</u></p>	<ul style="list-style-type: none"> • The student must be qualified in Reiki Healing at any level or any other certified energy healing therapy as described above. • The student must have a basic to advanced understanding how disease is created through thought, emotion and beliefs • The student must complete the three personal healing sessions of Systemic Pathways Clearing Healing to be ready to be attuned to this particular healing • Complete the enrolment form and satisfy the prerequisites by providing proof of qualifications, skills, abilities and work in energy healing and metaphysical/spiritual abilities if any at the personal interview prior to acceptance and enrolment on the course.
<p><u>Training & Student Contact Hours</u></p>	<ul style="list-style-type: none"> • Systemic Pathways Clearing Healing® Training is a face to face or online including Skype course taught over five weeks. One on one or in groups. • Total student and training contact time will be twenty hours face to face or 16 hours online and 4 hours on Skype or face to face in person.
<p><u>Requirements to become a certified Systemic Pathways Clearing Healing ® Practitioner</u></p>	<ul style="list-style-type: none"> • Complete the full Systemic Pathways Clearing Healing® Course and demonstrate their knowledge, understanding and practical skills that satisfy the requirements of performance criteria set out in the practitioner course. • Clinic setup, requirements, administration. How to conduct a healing session. • The student is required to demonstrate knowledge and understanding of the IICT Professional Code of Ethics and abide them. OH&S practises • The student is required to take out professional indemnity and public liability insurance offered through A J Gallagher or AON. Overseas students are required to do the same in their country of residence where the IICT is active and or where insurance is available.

<p><u>Weeks 1 & 2</u></p>	<ul style="list-style-type: none"> • What and how Systemic Pathways Clearing Healing supports and assists healing the physical systems of the body at cellular level including the corresponding energetic systems simultaneously. It purifies the physical systems which frees the pathways of each individual system. The results are the free flow of oxygen, blood, nutrition and energy through all systems which assists general health and wellbeing. Study online plus a Skype session with Nantah. • The student has their first and second Systemic pathways Clearing Healing session. These are conducted weekly until all three sessions have been completed and the student is then connected to this healing source.
<p><u>Weeks 3 & 4</u></p>	<ul style="list-style-type: none"> • The corresponding chakras connected to the Ten Physical Systems and how to determine blockages by the presenting physical problem of the client. The chakra system and the Physical Systems of the body they govern. • How disease is created in the body by thoughts, emotions, beliefs, past lives and DNA. • Conduct first Systemic Pathways Clearing Healing for volunteer client. One session each week of 3 & 4. Follow up results after the healing with clients.

The student also learns how to fill out the client healing form and inform the client of the systems that were worked on during each healing session. How to determine if a client needs a second and a third healing session. • The student is required to have the client sign the Disclaimer Form prior to the commencement of healing. The student is required to demonstrate their knowledge and understanding of the IICT Code of Ethics and practises and join the said association and take out insurance for their work if they do not already have insurance in place. The student is required to show knowledge and understanding of OH&S practises. • Student must complete their study case volunteer and email to Nantah's Spiritual School for final marking and assessment. This will also be reviewed in a Skype session prior to certificate being issued.
