In consideration of this opportunity to foster, I agree to the following terms and conditions, intending to be legally bound by them:

I will furnish a representative of FURRever Friends and Kitten Care Rescue the names, addresses and telephone numbers of two veterinarians so rescue can set up an account for care if one of ours is not close. If this is not possible, the foster will be required to submit the required payment or make other arrangements with FURRever Friends and Kitten Care Rescue. The foster will submit all invoices to FURRever Friends and Kitten Care Rescue within 5 business days. FURRever Friends and Kitten Care Rescue will reimburse the foster for the invoices as soon as possible after receipt of said invoices. All pet(s)' need to be under the rescue name for vetting and billing purposes so that they can be paid by the rescue and we receive rescue agreed pricing.

- Every animal coming in to foster care with FURRever Friends and Kitten Care Rescue will be vetted prior to placement, if possible. Sometimes this needs to be done while in your care due to time restraints. This will include:
  - Spay/neuter when necessary
  - All applicable vaccinations
  - Heartworm test
  - Microchipping

PLEASE NOTE: If there is an emergency or unforeseen veterinary care is necessary, FURRever Friends and Kitten Care Rescue should be notified immediately for approval. You will be provided with contact number of person(s) who can provide approval.

If there is a personal emergency, vacation scheduled, etc, please notify FURRever Friends and Kitten Care Rescue if arrangements need to be made for the care of the foster. If someone other than the person(s) signing this agreement will be responsible for caring for the foster, please advise FURRever Friends and Kitten Care Rescue, in writing or email, and furnish their contact information.

I agree that I will abide by the mission, rules, regulations, policies and programs of the FURRever Friends and Kitten Care Rescue Inc, while I am a foster.

I assume the risks of being bitten, scratched, injured or frightened by pet(s) and puppies or other FURRever Friends and Kitten Care Rescue animals in connection with my foster work for the rescue. The FURRever Friends and Kitten Care Rescue organization, officers and volunteers are not liable to me for any injuries, damages, liabilities, losses, judgments, costs or expenses which I might suffer or sustain in connection to the performance of my foster activities for FURRever Friends and Kitten Care Rescue unless they are the result of FURRever Friends and Kitten Care Rescue's gross negligence or intentional misconduct.

I will indemnify, defend and hold FURRever Friends and Kitten Care Rescue harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of foster activities for FURRever Friends and Kitten Care Rescue, or my breach of FURRever Friends and Kitten Care Rescue rules, regulations, policies and programs.

If I suspend foster activities, or upon FURRever Friends and Kitten Care Rescue request at any time, I will promptly return all rescue supplies, equipment, records, monies and other items in good, clean condition.

I will not have a person outside FURRever Friends and Kitten Care Rescue organization temporarily care for the rescue's animals (i.e. a visitor, pet sitter, neighbor, relative) unless the person first signs a Hold Harmless Agreement to hold FURRever Friends and Kitten Care Rescue, its officers and volunteers harmless in the event of injury or mishap. In the case of an adoption, an Adoption Agreement is to be signed to make the adoption final.

Any modification to this Agreement must be in writing and signed by both parties. This Agreement is binding upon FURRever Friends and Kitten Care Rescue, FURRever Friends and Kitten Care Rescue representatives, me and my respective heirs, successors, assigns, executors and personal representatives.

I agree to INDEMNIFY and HOLD HARMLESS FURRever Friends and Kitten Care Rescue for any costs or liabilities which they may incur as a result of my fostering for FURRever Friends and Kitten Care Rescue.

I acknowledge and agree that I have carefully read this Agreement, that I fully understand the same, and that I freely and voluntarily execute the same. I understand that I may seek independent advice prior to signing this Agreement. I understand that this Agreement is binding on me, my spouse, my executors, administrators, personal representatives and assigns and that this Agreement has important legal consequences. The terms of this Agreement are contractual and not mere recitals.

This Agreement will be construed in accordance with and governed by the laws of the State of Illinois.
