Eco Communities recognise Howbury Tumblers is a service much needed and supported by the local community, and we have a written agreement to occupy the premises rent free, so we can maintain low cost services for our families from this deprived area. We have a good working relationship with Eco Communities and as long as they are running the Centre I am confident our rent agreement will be honoured. We had Children In Need funding for the salaries of one of the Groups staff members, until March 2017, the second Play leader role. From April 2017 this wage was met from the general budget as decided by the Trustees( 20 <sup>th</sup> March 2017), but it was also decided that we needed to increase attendance fees for the first time since 2005, by 50 pence per child/ family, to cover rising costs of resources, including cleaning.		

Families were given a month's notice before the rise took place and we had no negative feedback about this – user numbers have continued to rise throughout this year.

Howbury Tumblers gives parents, carers and their children under five drop – in access to its provision from 9.15 to 2.45 Monday to Friday, term time only, for a small daily charge. Holiday family sessions are run in periods of group closure, and include provision for older siblings. The Charity also provides crèche services for Bexley Women's Aid & Slade Green Big Local Partnership who run training courses for parents at the Centre. The Group provides sessional staffing for outreach work, for Northend Wellbeing Centre, West Street Children's Centre, and Normandy Children's Centre (SEN group) supplying our staff – (former and current Parents at Tumblers, who have volunteered in the past and have gained training and gualifications) - to support a Crèche facility for families in need so they can attend training courses these providers run in and around Erith & Slade Green. We have also provided a 1:1 support worker during this year at Lime Row Nursery which is continuing into the new term September 2017. Through this means this year we have helped 3 Parents and one Work experience student into part time and sessional ( self) employment. As well as the management committee members, 9 Parent volunteers have been involved in helping to run the day to day activities and holiday events at Howbury Tumblers. Another volunteer helps out with the website management and administration.

Also we had 4 students on work experience placements, a GCSE student, an EYCD level 2 student, and 2 students through Skills For Growth.

The Staff have, this year, contributed much voluntary time, around 1000 hours .Carole Read has contributed in excess of 600 hours in Tumblers administration duties and also over 100 hours for Slade Green Big Local Partnership, having the role of Chair, at meeting, events & community engagement. Tina Ludlow, as part of her Grant, does around 10 hours of voluntary work a week, in addition to 15 paid hours. Parental Volunteer time is around 250 hours in total, within Howbury Tumblers and for SGBL, where voluntary work has included helping with events such as Christmas parties, leaflet delivery and helping set up and manage local events such as our Christmas & Community Celebration day, Community Farm day, Sports event, and Community Safety days. This includes 2 young volunteers, aged 17 years.

We are committed to keeping this as low as possible in order that we remain accessible to families in our identified area of need - Slade Green- the most deprived area in Bexley. We also have some income from the sale of refreshments, but again, we must remain cost effective to our clients. Our other source of income is through birthday parties and we hope to continue to increase the number of these through the next year. We have some income from the provision of crèche at Slade Green & Howbury Centre for Bexley Women's Aid, and through the provision of sessional staffing for outreach work for Northend Wellbeing Centre and other Children's Centre's , both of which bring in a little money to the Group and help secure our finances. We will continue to apply for grant funding for projects and equipment, and fundraise internally to help finances.
