Generation success provided 3 months of STEM workshops to students in grades 3 to 9. These workshops were free and held at the Norman Mayer branch library for 2.5 to 3 hours each. Students who attended were able to learn coding, robotics, chemistry and physics, and mathematics. Students were provided with lunch or dinner, depending on when the workshops were held, and a snack. Further, students got to take access to an online learning platform that will continue to build their skills in coding and computer gaming design.

Students in New Orleans received free school supplies at the start of the year. These supplies included, backpacks, notebooks, pens, pencils, crayons, binders, rulers, socks, and other miscellaneous needs for the start of school. Parents were able to reach out and 1 family's complete list of needs were taken care of for 2 children.
