Understanding this, I agree to assume any and all risk of injury and financial loss that may arise from participation in such activities, including the liability thereof. I understand that these risks include, but are not limited to falls, collisions, equipment interactions/malfunions, terrain conditions, and all other occurrences that can cause any injury as a result of my own, or others, conduct or inexperience.
