- Clean tack in good repair may be dropped off at the Clubhouse on Thursday or Friday evening March 7th and 8th between 4 and 8 pm
 - Only designated representatives will accept tack. If you leave it with Someone else it will not be included in the tack sale.
 - No items will be accepted for sale on Saturday or Sunday.
 - The Hunt Club earns a 20% commission on items under \$100.00, a flat \$25.00 on items \$100-\$400 and an additional \$25.00 in \$400 increments on items over \$400.00.
 - It is your responsibility to figure the commission into your sale price. The price marked on your item includes our commission. If your tack does not sell on Saturday, we will allow you to reduce your price on Saturday between 2 pm and 3 pm.
 - We do not negotiate sale prices of items.
 - A representative of the Hunt Club will issue checks between 10 am - 2 pm on Sunday. **PLEASE PICK UP ANY UNSOLD TACK ANY TIME SUNDAY BEFORE 1 PM SUNDAY.**
 - All Goods are left at your own risk. HHRC is not responsible for lost or stolen items
