B). Administrative Report

Pam went over the two (2) properties that are currently slated for the assessment lien sale on December 4, 2018. She also commended Diane George for her diligence in collecting the delinquent assessments that had originally totaled over 45 properties in the past 30-45 days.

C). Project Status Report

Wayne updated the Board on the WWTP work being done to continue the Phase 4 project and the finalization of the documents for bidding the residential connections for the Phase 4 project. He said that he had met with the County on the septic tank abandonment issue and that it had been worked out. He also said that drilling had begun at the Phase 5/6 WWTP site and WOOD has completed the 50% plans for review. He also talked about the wet wells at Keys 1 & Keys 2 lift stations and the plans to recoat them. He said the District is seeking proposals for that work. He also talked about exhausting all attempts to locate a company to identify all of the illegal storm water connections to the sewers. He showed the Board a device that can be used with manpower to detect these connections with smoke...similar to a fog machine. He said he would do some more research on the labor cost side and bring it back to the board.

5. (Action Item) Discussion and possible action for the Board to authorize the District Manager to advertise for Bids and RFP Documents for the supply of Goods and Special Services relating to Equipment Procurement (Pre-selection) of the advanced secondary treatment process for the Buckskin Sanitary District Phase 5/6 Wastewater Treatment Plant Design.

Wayne explained that the new WWTP needs a secondary treatment process and that this item is the RFP to obtain proposals for a complete system including equipment for sludge holding basins. The proposals are to include pricing, equipment layout, equipment data, ops and maintenance data allowing the District and the design engineer to pre-select the secondary treatment system process and manufacturer before the design is completed.

Director Jay Clagg approved the item as read Chairman Jeff Daniel seconded *Vote – 3-ayes* 2-absent
