Each proposal shall be made out in the form set forth in the Contract Documents and all pages of said Contract Documents book must be submitted as part of the proposal and shall be accompanied by a bid bond payable to the Buckskin Sanitary District of La Paz County, Arizona for not less than ten percent (10%) of the amount of the bid. The above-mentioned bond shall be given as a guarantee that the entity submitting the related proposal will enter into the Contract if awarded to such entity, and will be declared forfeited if the entity submitting the related proposals refuses to enter into the Contract after being requested to do so by the District Board of Directors.
