

## Pet Rescue Program

### Welcome to the NAWS Pet Adoption Program!

Completion of the following application is requested so that we can assist you in the selection of a new pet. This form and a consultation with a NAWS representative are designed to help you find the cat most compatible with your home and lifestyle.

#### In order to be considered as an adopter you must:

- Be 21 years of age or older.
- Have identification showing your present address.
- Have the knowledge and consent of your landlord, if applicable.
- Be able and willing to spend the time and money necessary to provide training, medical treatment, and proper care for a pet.

#### A few pieces of information:

- Completion of this application does not guarantee adoption of a cat. There are numerous reasons why an application may be rejected in general, or for a particular pet, depending on the needs of each pet. Please do not take offense if this is the case. We have these pets in our program for a while and truly get to know what each of their needs are, and what type of home is most suitable for each of them.
- Adoption fees generally range from \$75-\$125. As a matter of information the pets in our rescue program are just that, rescues. This means that most of them come to us without ever having been vetted not spayed/neutered; no vaccines; some come to us with broken/ fractured bones and other conditions needing treatment. If you average out the amount of money that our organization spends on vetting, each cat would have approximately \$250 of vetting in them! We are not a large humane society with members, or have a township that provides us with funding, we are a small group that is funded solely by a few donors and a wonderful fundraising committee. We are truly a small group of people that love and respect animals and give all of our extra time and money to help as many animals that we are able to.
- Please note that there are sometimes several people/families interested in the same cat or kitten. There can obviously only be one family or person chosen to adopt a cat, and it is NAWS' responsibility to the cat and to the potential adopters to select the person or family that is best suited for a particular pet. We do understand that this sometimes can cause hurt feelings and it is certainly not our intention to do so. It is actually a much nicer problem to have more than one good home for a homeless pet than none at all! Please understand our position and that our number one responsibility is the best possible placement for each pet.
