Policies

- All foster parents must be at least 21 years of age and must have significant experience with cats.
- In keeping with the Department of Agriculture rules, an in-home visit by a NAWS coordinator should be conducted, and should be expected periodically.
- Foster homes must fully disclose the number of animals in their household at any given time, and must be spayed/neutered.
- Foster pets are the "property" of NAWS and only NAWS may adopt them out, and NAWS has the exclusive right to make decisions on behalf of the pet, and can remove the pet at any time.
- Fosters must follow the Humane Care for Animals Act and any violators will be prosecuted to the fullest extent of the law.

Processes

- Foster pets are generally rescued from high-kill shelters, animal control facilities, abuse and neglect cases, strays found in the environment, and owner relinquishments.
- Foster parents will be contacted if there is a cat or litter of kittens that need to come into the program. We will do our best to provide you with all of the information we can regarding medical and other care that will be needed to allow you to make an informed decision. If the foster parent wishes to foster that cat or litter, NAWS will coordinate next steps with you.
- If a foster family finds a pet on their own that they would like to foster, they should contact the program director to see if that pet can become a part of the NAWS rescue program.
- Once in foster care, when pets need follow up veterinary care the NAWS staff will coordinate appointment dates/times with you.
- If the pet becomes ill or injured, the foster parent should contact the NAWS Animal Clinic if it is during business hours, and let the staff know that you have an urgent situation and need to make arrangements to have the pet brought in. If after hours, please contact Wendy Paul, Stacy Gaskins or Jeannine Huck for guidance. If you cannot find Wendy, Stacy or Jeannine for some reason and you feel the pet is in danger, please do not hesitate to contact the Mokena Emergency Clinic and let them know you're coming in. NAWS has an account established there. Note PLEASE try your best to get approval from us prior to using the ER.

- Foster homes are responsible for providing food, water, shelter, and proper/kind care. NAWS will provide all veterinary care. We will provide food and other supplies if necessary as well.
- Some foster families have asked if they are allowed to adopt their foster pet and yes, we do allow that provided it is truly a good long-term match. The only down side for us is that we sometimes lose a foster family then, but some continue to foster even after adopting. We just want what is best for the pet, so we're very open to the idea!



RELEASE AND WAIVER OF LIABILITY – Pet Foster Activities

I hereby release and forever discharge NAWS, and its employees, volunteers, directors, officers, administrators, agents, and assigns (herein collectively referred to as NAWS), from all liability for any and all claims, demands, actions, causes of action or suits of any kind or nature whatsoever and particularly on account of any injuries (e.g., including, but not limited to, dog bites), both to person and property, including without limitation to any animals owned, fostered, or supervised by any attendee and/or economic and non-economic losses which I may suffer, which may result from, or develop in the future as a result of my participation in any event or activity sponsored by NAWS. I further agree that if, despite this Release and Waiver of Liability, I or anyone on my behalf makes a claim against NAWS, I will indemnify, save and hold harmless NAWS from any damages, losses and expenses including, but not limited to, legal fees, courts costs, and litigation expenses.

I agree that any injury, damage, or loss, of any kind whatsoever, to any person, animal, or property at any NAWS event, caused by my pet is solely my responsibility and I will indemnify, save and hold harmless NAWS from any damages, losses and expenses including, but not limited to, legal fees, courts costs, and litigation expenses.

Neither this waiver nor the circumstances leading to its execution shall be deemed an acknowledgement by NAWS that, as of the date hereof, any such claim exists or will exist or that the activities and events of NAWS are hazardous or present any unusual risks.

This release is binding on my heirs, executors, assigns and administrators. The undersigned is aware of the risks of attending, traveling to and participating in said events or activities and hereby assumes all risks. The risks include those foreseen and unforeseen, known and unknown.
