Treasurer's Report

Current balances as of 31st October 2016:

PL24 Community Association: £3,750.32

PL24: £505.98

SK8: £2356.37

Other Accounts: £252.00 (money held on behalf of Par Sports and Leisure Park which still does not have a bank account)

Total Account Balance: £6868.67 (includes the £750.00 as Cornwall Council's contribution for the Youth Market)

The Treasurer reported that two large payments would be going out shortly (one to Pegasus Printers in the sum of £1,250.00 for the magazine) but that £1,300.00 worth of advertising space has been sold.

Youth Market – this is still breaking even - £750.00 for the Marquee (from Cornwall Council) and £90.00 has been taken in stall fees

Constitution and Voting System (members of Association) for AGM

GB reported that she, TN and EW had met in this regard, following which it was decided that anyone can be a member of PL24 CA. If people sign in on entry to the AGM, as long as they provide PL24 CA with their contact details, they are then deemed to be members of PL24 Community Association and on that night they are allowed to vote. In order to do this, however, an amendment is needed to the Constitution, ie "This Constitution may be amended at an ordinary meeting of the Association by a vote and will require a two thirds majority of those members present in voting." An addition has been made to that part of the Constitution which states, "Membership shall consist of supporters of the Association and shall be free and open to residents of PL24 and other interested persons," and this amendment is, "Those wishing to become members should give their names and contact details. They are then eligible to vote at an AGM."

All members of the Committee were happy with the amendment and the proposal was agreed unanimously.

Following the AGM, YE to oversee the correlation of the list of members' details. 'Mailchimp' has been set up but needs more work before it can be used in this regard.

AGM and Food

The disco is free. Prizes will be needed, however, to give out at the disco. It was agreed that £20.00 could be spent on spot prizes for the disco.

JA – Sandwiches (Tuna, Egg)

It was agreed that 40 pasties from Havannas Pasties should be ordered at a cost of £0.65 per pasty. GB to order.

GB to ask JM if she would provide some crisps.

Travelling expenses for Cabaret

The Sixpenny Piece will be singing sea shanties, mining songs and Christmassy stuff and are free apart from their expenses. Some members of their group live in Liskeard and it was proposed that EW should bring along £20.00-£30.00 in loose change to give to them on the night. Agreed.

Youth Market

GB reported that the electricity generator will have to be paid for. The whole point of the Market was not to raise money but to encourage young people to get involved in doing something positive. TN said that Aussie Marquees will need a good deal of time to set up; GB to contact them to find out how long they will require (if they set up a day before the Market, then security will be required to safeguard the marquee overnight).

Better signage will be required but the Association cannot afford to buy this. Sam at the Market has promised to advertise as best she can but cannot help with signs or banners. JA to look into the making of banners: GB to look at the banners she has at home and discuss with the company next door to Pegasus Printers; TN to look into signage.

Volunteers – EW can help at the start only; MF can help at the beginning and at the end; CB unavailable; JM can help at the beginning. JA, TN and GB available.

Posters – GB to give 20 laminated posters for Youth Market and 20 laminated posters for AGM to MF tomorrow. MF to ask John Page about putting up posters in Tywardreath. TN has already put up posters for the Youth Market and the AGM in St Blazey.

Chestnuts and Carols, 17th December 2016, in aid of Friends of Doubletrees

The ladies of the Gott Hall Church have offered to provide coffee, tea and hot chocolate in the Gott Churchyard and the Choir will sing outside the Post Office. Someone is still needed to roast the chestnuts – GB to ask Mike Gascoigne if he would be available. Failing that, GB to ask Colin and Lawrence, Penny and Denise. Re the risk assessment, a sign to be erected at the bottom of Par Green to warn drivers of the event (because it is being held on two sides of the Green). GB to inform Rebecca and Jamie, PCSOs.

Round the Table Reports

GB – PL24 magazine is out, EW, TN, MF and GB delivering. Date Change – it was decided to bring publication forward rather than put it back, as discussed in the last meeting, so the magazine will now come out in March, June, September and December. TN suggested that the name 'Pegasus Printers' should appear in the magazine. Agreed.

MF – Friends of Par Beach Quiz was a great success. FoPB is now well into the winter working parties and new members came along to these (they are open to anyone, not just members of FoPB). At the last working party, more than 12 people came along. A Fungi and Lichen event was held at which a

scientist who used to work for Plymouth University came down - the event was well supported. There will be one more working party in November before these shut down for Christmas. Working parties begin again in January.

JA - St Blazey Community Room is nearly finished. The carpet went down today and the furniture will arrive soon. JA reported that there is going to be a Pasty Museum in 'Cornucopia', at Cornish Market World. Furthermore, the town of Real del Monte in Mexico has a Pasty Museum and has approached St Blazey Town Council with regard to twinning. Not only that but they have said that they would pay for one member of the Council to go over there. Cornucopia, which will be open all the time, is going to be an active museum where the public can make their own pasties, and importantly it will come under St Blazey, not St Austell.

TN – things are going well. Cornwall Council has given money for events such as the Youth Market, and sponsorship for the Christmas Card Competition has been very forthcoming. Cornwall Council has given £150.00, St Blazey Town Council has given £50.00, and £100.00 has been received from Roslyn Coaches, James Kittow and ANC Training.

EW – questioned if the £350.00 contribution from Imerys was a one-off or an annual donation. GB to find out.
