NCASA HALL OF FAME AND HALL OF HONOR

The North Carolina ASA has established a Hall of Fame and Hall of Honor to recognize our outstanding softball citizens. The purposes of each are for the Hall of Fame - To honor those players who have distinguished themselves and North Carolina Softball, and Hall of Honor - To honor those non-players (such as managers, sponsors, umpires, commissioners, meritorious service) who have made outstanding contributions to North Carolina Softball.

Eligibility for induction is as follows:

- A. Hall of Fame (1) Players only; (2) Will be inducted according to the class of softball in which they played the majority of their career; (3) Must be retired for two (2) consecutive seasons;
 (4) Must have played a minimum of ten seasons;
 (5) Must have distinguished themselves through All-American and All-State Honors and championship play.
- B. Hall of Honor (1) Must have made and outstanding contribution to N.C. Softball; (2) Will be inducted according to category in which they served and active members may be inducted; (3) Will be selected according to the following guidelines:
 - a. Managers Must have been a manager for at least 15 years, and distinguished themselves through championship play.
 - b. Sponsors Must have been a sponsor for at least 15 years, and distinguished themselves through championship play.
 - c. Umpires Must have umpired for at least 15 years, and distinguished themselves through championship play.
 - d. Commissioners Must have been a commissioner for at least 15 years, and made an outstanding contribution to NC Softball.
 - e. Meritorious Service Will include those individuals not eligible under another category who have made outstanding contributions to NC Softball. Will include such people as sportswriters; financial contributors; administrators; and organizers.

NCASA is presently receiving nominations for both Halls. Nominations must: (1) Be made by or through an ASA commissioner, and must be in by April 1 in odd-numbered years to be considered that year; (2) Must include a written presentation listing accomplishments of nominee. Presentation may include statistics, honors received, accomplishments and contributions to softball. May also include any materials such as news clippings, program and handbook showing actions of nominee.

Selection will be made by a nine-member committee and a candidate must receive two-thirds majority of committee vote (6 votes). Those selected to enshrinement will be presented a commemorative plaque and will be asked to provide the NCASA with a memento to be exhibited in the permanent Hall.

Selection Committee:

The Selection Committee shall be appointed by the North Carolina Amateur Softball Association Commissioner and approved by the Executive Board of Directors of the North Carolina Amateur Softball Association. The Selection Members may be active or retired softball participants. The NCASA Commissioner shall appoint a member of the committee as the chairperson. The NCASA Commissioner shall act as an ex-officio member. This member shall have voting privilege.

Every effort shall be made to insure equitable representation from all areas of the state and the ethnic and gender background of the selection committee shall be representative of our state.

Selection Committee members shall serve three-year terms and the initial appointment shall be staggered to insure continuity of the selection committee. On recommendation from the NCASA Commissioner the Executive Board of Directors may approve a Committee member to serve beyond the three-year term.

The NCASA Commissioner or his/her designee shall serve to receive all correspondence and field questions relative to the selection process.

The Selection Committee shall be charged with reviewing all correspondence received for each candidate. By secret ballot, the Selection Committee shall decide inductions to the NCASA Hall of Fame and Hall of Honor.

Nominations:

Persons nominating a candidate must submit an NCASA approved application to the office of the NCASA Commissioner. The application and all relative correspondence must be received by the NCASA Commissioner no later than the last Saturday in January on odd-number years to be considered that year.

Please review candidate qualifications as specified in the NCASA Hall of Fame and Hall of Honor page.

Meeting:

The Selection Committee shall meet in the spring on odd-number years to review applications and correspondence of nominees and decide which candidates are to be selected.

Limitations:

There shall be no limit placed on the number of inductees selected on odd-number years.

Awards:

Hall of Fame inductees shall receive an appropriate plaque and medallion furnished by the North Carolina Amateur Softball Association and shall be formally inducted at the Hall of Fame and Hall of Honor Banquet. Space in the North Carolina Amateur Softball Association Hall of Fame Building shall be set aside to commemorate the inductees.
