Please check the dates the camper will attend: There will be a \$10.00 a day fee for no-shows if you do not notify the office at least one week in advance of changes or absences. This fee is to reserve your child's spot in the program. **IF A CHILD ATTENDS ANY PART OF A WEEK, THE FULL WEEKLY RATE APPLIES.** Camp fees are due each Monday morning upon sign-in for that week.
