IN CONSIDERATION of my/the minor's participation in any way in any Amateur Athletic Union of the U.S., Inc. ("AAU"), activity ("ACTIVITY") I, for myself, the minor, my personal representatives, assigns, heirs, and next of kin: 1. ACKNOWLEDGE, agree, and represent that I understand the nature of the Activity and that I am/ the minor is qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I/ the minor will immediately discontinue further participation in the Activity. 2. FULLY UNDERSTAND that: (a) ATHLETIC ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own/ the minor's actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur/ the minor incurs as a result of my/the minor's participation in the Activity. 3. HEREBY RELEASE, AND FOREVER DISCHARGE, AND COVENANT NOT TO SUE the Amateur Athletic Union of the U.S. Inc. ("AAU"), the Host, Local Organizing Entity, their parent, related, affiliated, and subsidiary companies, as well as the officers, directors, agents, attorneys, employees, representatives, successors and assigns of each of the foregoing entities, and the AAU's Associations, clubs, coaches, officials, administrators, members, volunteers, participants, sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, and any other party indemnified and held harmless by the AAU, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY/THE MINOR'S ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE ACTION, INACTION OR NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING, BUT NOT LIMITED TO NEGLIGENT RESCUE OPERATIONS, NEGLIGENT SECURITY, TRAVEL, AND RECREATIONAL OPERATIONS AND ACTIVITIES; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my/the minor's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

Code of Conduct for Parents:

Parents, you are key to the success of the players. We encourage your positive involvement. We request that you abide by the following code of conduct:

- I will encourage good sportsmanship by demonstrating support for all players, coaches and officials at every game, practice or other events.
- I will place the emotional and physical well being of my child ahead of any personal desire to win.
- I will provide support for coaches working with my child to provide a positive, enjoyable experience for all.
- I will remember that the game is for the players and not the adults.
- I will set a positive example at all games by respecting and interacting positively with the officials, opponents, coaches and fans.
- I will address any concerns I have to the coach. If deemed necessary, a meeting will be set up between the parents and coach.
- I will advise and help my child after, not during, any game. I will depend on the coach to correct or coach during all games. I understand the best way to help my child is through positive enthusiasm and reinforcement.
- I understand that the coach will make effort to play all eligible team members each game, but equal playing time cannot be guaranteed.

Inappropriate parental actions may result in a warning or suspension of a parent from attending practices and/or games. Redline Volleyball Club makes these decisions and the decisions are final.

Remember- Mistakes will happen. Those on the court are only human. Give them the benefit of the doubt and be patient. Above all, come out and support your child and the program. Enjoy yourselves and allow others the same opportunity.

Code of Conduct for Athlete:

As a team member, I represent Redline Volleyball Club and my behavior both on and off the court is important to the success of the program.

- I will listen to my coaches and respond to them in a positive manner.
- I will support my teammates by using positive statements, actions and gestures.
- While on the bench, I will remain positively involved by cheering on my teammates.
