

# Living Shoreline Contract



Thank you for your interest in having Carolina Silvics, Inc. ("Contractor") obtain permits for and install living shoreline stabilization on your property. This form contains the Agreement ("Contract") and basic information about your proposed project. If you have any questions about this Agreement ("Contract"), please call our office at 252.482.8491.

**Deposit:**

Please note that before permit documentation can be prepared, a non-refundable deposit of \$500 must be received by our office.

**Final Payment:**

Payments for all permitting and stabilization activities are to be paid as follows:

50% of the contracted amount is due upon receipt of your permit and scheduling installation.

The remaining full and final payment is due within thirty (30) days of installation.

If a different payment arrangement is requested, Carolina Silvics, Inc. must approve it in writing before installation. Payment can be made via check, bank draft (online) or credit card (online). Payment by credit card will incur a handling fee.

***Please notes that CAMA General Permits are valid for 120 days from the date of permit and Major CAMA Permits are valid for one (1) year from date of permit.***

**Agreement**

All prices include landowner coordination, NC Coastal Area Management Act permit preparation and submittal, coordination with NC Division of Coastal Management staff, all necessary labor and materials, and site clean-up upon completion.

Use of any and all equipment necessary to complete the project is authorized provided it causes no detriment to the property. In the event of any damage to property cause by Contractor, Contractor will immediately repair such damage to the condition it was before Contractor's damage.
