Regular Registration Fees

*This is the last date registration fees will be accepted at the regular registration rate. Registration must be completed on-line prior to this date for regular registration fees to apply. Registrations may be refused if meeting capacities are reached. Payment may either be mailed in advance or presented at the conference registration table.

Late Registration Fees

- 2. Late Registration Any chapter registration submitted after the regular registration deadline will be charged the late registration fee, so register early!
- **3.** Make copies of the completed form send one copy to the address below and keep one copy for your records. Payment for registration may either be paid in advance via mail or presented at the registration table on site. Please make every effort to pay in advance.
