Directions to Trial Site: From 27N: take the Morrison Springs Road exit toward Red Bank at mile marker 6.6 (don't take the Dayton Blvd / Red Bank exit at mile marker 3). Turn right at the end of the exit ramp. Get into the left lane, and go a third of a mile to the end, then turn left onto Dayton Blvd. Go a quarter mile, we're on the left.

From 27S: take the Morrison Springs Road exit toward Red Bank. Turn left at the end of the exit ramp and follow the directions above.

From 24W: take the 27N exit and follow the directions above.

From 75N: take exit #2 for I-24 West towards Chattanooga/Nashville then follow the directions above.
