## Adoption Agreement

Please read before signing. A copy of this document must be provided to both the person adopting and the Adoptable admin, which will then be kept on the animals file for records. One adoption agreement per animal.

**By signing this document you agree to the following:**

- The 2 week trial period commences from the date you pick up and pay for the animal. Should you feel during this period that the animal is not suitable, it may be returned to Adoptable Pet Rescue and you will receive a refund of the purchase price of the animal less a \$50 admin fee.
- If you decide to return the animal during the trial period, it is your responsibility to return the animal to Adoptable Pet Rescue at your own expense.
- You must maintain and house the animal in conditions that comply with the current standards as outlined by the DEPI. You agree to abide by any state laws relevant to the safety of the animal during and after the trial period.
- You will ensure that the animal is registered with the local council in your municipality
- You will ensure your animal wears an identification tag and collar at all times.
- You take responsibility for any damage or injury caused by the animal during the trial period. Should any damage or injury occur, it is recommended that you return the animal to Adoptable Pet Rescue as soon as possible. After the trial period is completed, you become legally responsible for the animal and its actions under Local, State and Federal law.
- We do not guarantee the animals age, breed, adult size or temperament. You accept an animal at your own risk. We are not responsible for any death, damage or injury to persons, animals or property which may be caused by the animal during or after the trial period.
- You DO NOT become legal owner of the animal until the completion of the adoption paperwork, payment, the two week trial period and the microchip is registered in your name.
- If at any point through your animals lifetime you can no longer care for the animal due to change in circumstances or change to the animal, Adoptable Pet Rescue will of course take the animal back into our care no questions asked. We request that you contact Adoptable Pet Rescue if you are no longer able to offer the animal a forever home and Adoptable Pet Rescue will find a more suitable home.
- After the trial period, if you wish to surrender the animal back to Adoptable Pet Rescue, you must do so with the understanding that no money can change hands. Adoptable Pet Rescue will happily re-home the animal.
- You are responsible for any costs incurred should the animal be impounded by council, RSPCA or other authority, during or after the trial period. You must notify Adoptable Pet Rescue and pay to have the animal released even if you no longer wish to retain ownership.
- During the trial period, should the animal require medical attention, you will contact Adoptable Pet Rescue and follow the directions given. Any vet costs incurred will not be refunded unless the animal is presented to a clinic agreed to prior to the appointment by Adoptable Pet Rescue. Should the animal be injured (such as in a road accident), all veterinary costs are your responsibility, not Adoptable Pet Rescue. However, Adoptable Pet Rescue should be notified immediately.
- An animal adopted from Adoptable Rescue cannot be sold or used to make any profit for the new owners or persons associated with those owners.
- Should at anytime during or after the trial period, Adoptable Pet Rescue is of the belief that an adopted animal is being mistreated or at risk, Adoptable Pet Rescue may seize that animal without notice. The animal will only be returned to the possible new owner after Adoptable Pet Rescue considers the situation resolved and the animal faces no further threat. Should Adoptable Rescue feel the situation cannot be resolved then they may list the animal for re-homing whereby the owner will receive no money or refund.
