

If, because of riots, civil disturbances or other acts beyond the control of the club and committee, it is impossible to open or to complete the show, no refund of entry fees will be made.

A recording fee of 50 cents and an AKC Event Service Fee of \$3.00 will be required for each dog entered at any licensed or member club show. These fees are to be collected by the show giving club and paid to the AKC. If a dog is entered in more than one class at these events, the AKC Recording Fee is to be collected on the first entry only and the AKC Event Service Fee is to be collected on each of the entries of that dog. (AKC Rules, Chapter 11, Sec. 2). (There is NO Recording Fee of Event Service Fee for Sweepstakes or Special Attractions).

Returned Checks do not constitute a valid entry fee. The Secretary will add a collection fee to each returned check. No unentered dogs or puppies will be allowed inside the show limits.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. During the hours of judging owners are to be on call and have their dogs ready to bring into the judging ring promptly, in order that the judging will not be delayed. The Club and its' Show Secretary will not be responsible and are not obliged to furnish any service for notifying exhibitors or their agents of breed or class judging. The Judges will not wait for any dog holding up a class.

A dog which, according to its owners' records, has completed the requirements for a Championship after the closing of entries for the show, but whose Championship is unconfirmed, may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made by the Show Secretary at least one half hour prior to the start of any regular conformation judging at the show.

The club will not be responsible for the loss of, or damage to any dog exhibited, whether the results of accident or other causes. It is distinctly understood that every dog at this show is in the care, custody, and control of his owner or handler during the entire time the dog is on the show premises.
